Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

It was moved by Quist and seconded by Kruger to approve Valuation Changes for 4-26-2016 as presented by the Assessor. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hinehline. Nay: None. Motion carried.

At 4:05 A.M., there being no further business to come before the Board of Equalization at this time, it was moved by Quist and second by Hinehline to adjourn meeting until the next Board of Equalization meeting date, May 9, 2016. All members present voted aye, Chairman declared meeting adjourned.
