The Washington County Board of Equalization of Washington County, Nebraska, met in regular session at 4:00 P.M. on Tuesday, June 28, 2016 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. It was moved by Quist and seconded by Hinehline to approve valuation changes for four Deerfield Additions as presented by the Assessor. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hinehline Quist, and Kruger. Nay: None. Motion carried.
