## January 12, 2016 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County met in regular session at 8:30 AM on Tuesday, January 12, 2016 in the Supervisor's room at the Courthouse, Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgement of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

County Clerk, Merry Truhlsen, declared the reorganization meeting for 2016 was in session and that the meeting is being recorded. Clerk made note that the Open Meetings Law is posted on the door and the north wall. Present: Paul Cerio, Lisa Kramer, Mary Alice Johnson, Jeff Quist, Steve Kruger, Carl Lorenzen and Ronald Hineline. Also present, County Attorney Scott VanderSchaaf.

Clerk requested nominations for Chairman. Cerio nominated Lorenzen. Motion by Quist second by Kramer that nominations cease. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. Chairman Lorenzen called Point of Order regarding electing a vice chairman, saying statute does not provide for a vice chairman. VanderSchaaf concurred and said adopting by-laws could address the issue.

Co Atty requested adding a closed session to the agenda in order to protect the public interest; whereby attorney client privilege discussion will ensue with respect to officials' salaries. Kruger moved, seconded by Cerio to approve the agenda for January 12<sup>th</sup>, 2016 with the addition of a closed session on officials' salaries. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. It was moved by Quist and seconded by Kruger that the rules be suspended and that the minutes of the Dec 22, 2015 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Motion Kruger second Hineline that the following monthly fee reports be received and placed on file: Co Clerk \$310, Reg of Deeds \$40,885, Co Court \$16,486, Co Plan Dept \$10,647, Clk Dist Crt \$4041, Co Sheriff \$3,027 and Road Dept \$207,171. Treasurer's Dec. statement: Collections 1,739,213; Disbursements 1,741,305; Ending balance \$5,483,347. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. The following correspondence had been received: Rd Dept received a check from NIRMA for \$2,887.64 towards the purchase of first aid kits and safety items. It was moved by Quist and second by Cerio that correspondence be received and placed on file. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Next item of business was to designate depositories for County funds. It was moved by Hineline and seconded by Kramer that Washington County Bank, Two Rivers Bank and the Nebraska Public Agency Investment Trust (NPAIT) be designated as depositories for County Funds in 2013. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. It was moved by Hineline and seconded by Quist to authorize County Treasurer, Marj Hoier, to invest County Funds in any of the designated depositories. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

At 8:45 AM, motion Hineline second Quist to recess from Board of Supervisor's meeting to go into Board of Equalization. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. See separate minutes. Board reconvened in regular session at 8:50 AM.

Mike Smith, Weed Dept, discussed year end reports. Motion Hineline second Cerio to approve Weed Dept yearly reports and authorize Chairman to sign. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Bob Smith and Rollie Husk, Road Dept Foremen, discussed the offer from NDOR, saying the County doesn't have a need for the broken concrete/milling materials at this time and that the transportation would be costly. Motion Kruger second Hineline to formally decline Nebr Dept of Road's offer of broken concrete and milling materials. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Smith handed out 2 forms: Waiver for Removing Stuck Vehicles and form for installation of a driveway culvert. Smith discussed the current form and procedure for installing culverts and possible changes to that. Motion Kruger second Cerio to table this until the next meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Smith gave an update of the road/bank erosion occurring east of Ft Atkinson on Co Rd 34 and erosion on Co Rd P25. Board discussed the areas. Motion Cerio second Hineline to table this until more information is received from the engineer. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Bob Denton, Chief Probation Officer, District 6, gave an update on the County's Diversion Program and Drug Court. Steve Ortmeier spoke about the benefits of the Diversion Program detention alternatives. VanderSchaaf spoke. Patty Lyon spoke and gave Board a numbers sheet on the Drug Court participants. Board discussed the information.

Alan Kohll and Kurt Beisch discussed the USA Triathlon event, to be held in August 2016, which includes areas in southeast Washington County. Beisch handed out a list of county residents that live along the route. Board discussed the race. Sheriff Robinson spoke. Dennis McCormick spoke in favor of the race. Motion Cerio second Kramer to table action on this until county residents have been notified and the interlocal agreement with Douglas County is in place. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger and Lorenzen. Hineline absent. Nay: None. Motion carried.

VanderSchaaf discussed getting public input on the proposals from Prochaska & Assoc regarding the Washington County Law Enforcement & Detention Center. The proposals are on the County's website. Board discussed getting representation from different areas in the County to serve on the committee. Motion Kruger second Hineline to have Prochaska & Assoc go through a presentation of options outlined in their Preliminary Concept Planning for the Wash Co LE & Detention Center at 5:30 PM on Monday, January 25<sup>th</sup>. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

VanderSchaaf discussed alleged FEMA violations and noncompliance of Planning and Zoning Administrator to provide the requested information in an email, as he wanted to read through the material. Tanna Wirtz, Plan & Zon Admin, explained she had requested meeting with a member of Co Atty's office to clarify the email request. Motion Hineline second Cerio to have Plan & Zoning Admin provide documentation regarding violations over to the County Attorney, answer the email of 12/9 and set a timeline of 30 days to provide this information and future violations to the Co Atty's office. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Clerk asked Board to change the dates of 3 Board meetings due to a conflict with elections. Motion Kruger second Quist to change the second meeting in January to Monday, 25<sup>th</sup> and the first meetings in May and November to Monday, May 9 and Monday, Nov 7. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Motion Kruger second Hineline to designate notice of meetings will be published in the local newspaper: Enterprise and Pilot Tribune, on the County's websites <u>www.co.washington.ne.us</u> and for emergency situations will post a notice at the Courthouse. Clerk requested permission to figure Official's deputies' pay at hourly rates due to reporting requirements on check stubs. Steve Mencke spoke about increasing deputies' pay. Motion Johnson second Kruger to round deputies' hourly rates up to nearest penny. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.
