Board discussed getting countywide representation on the Citizens Advisory Board for Jail Study. Steve Mencke, County Assessor, had given the Board information for various computer/server updates with Right Tech. Kramer suggested the County purchase servers themselves, and not purchase them through Lantex. Board said they don't have a contract with James Overton, Lantex, yet.
