The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 4:08 p.m. on Tuesday, February 23, 2016, in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Carl Lorenzen declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Carl Lorenzen, County Board Members, Paul Cerio, Lisa Kramer, Mary Alice Johnson, Jeff Quist, Steven Kruger and Ronald Hineline. Also present, County Clerk Merry Truhlsen and Co Atty Scott VanderSchaaf.

Motion Cerio second Kramer to approve agenda for February 23, 2016. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. It was moved by Cerio and seconded by Kruger that the rules be suspended and that the minutes of the February 9, 2016, meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. The following correspondence has been received: Lodging Tax for 2015 April through Dec, 9 months, is \$10,231 and letter from NDOR regarding a statewide mobility management project. It was moved by Kramer and seconded by Cerio that the correspondence be received and placed on file. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Road Dept. Foremen Bob Smith and Rollie Husk were present. Smith handed out copies of an email from Jon Mooberry, JEO Consulting Group. JEO is working on a preliminary design for CR25 embankment stabilization. Road Dept will be doing that project. JEO is waiting for direction from the Board on the reconstruction of CR 34 east of Ft Calhoun. Mooberry has talked to NDOR regarding the Kennard SE, CR32 project. CR32 will be closed for a time as construction on Hwy 133 continues. JEO suggests doing dirt work on CR32 in summer & fall of 2017. Motion Kruger second Kramer to have JEO do core samples and start the preliminary design for the Kennard SouthEast, CR32 Project. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Smith and VanderSchaaf discussed putting an addendum in the Personnel Manual changing how overtime hours are figured for Road Dept employees. Motion Cerio second Hineline to refer the Road Dept overtime addendum to the Road Committee and County Attorney for verbiage. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Kramer absent. Motion carried.

Steve Riley, Prochaska & Assoc, had submitted a letter of agreement for Phase 4 services, which consists of working with the Citizen Advisory Committee to review the results of the Phase 2 Needs Assessment and the Phase 3 Preliminary Concept Planning. Board discussed the proposal. Motion Cerio second Johnson to approve Phase 4 services with Prochaska & Assoc to work with the Citizens Advisory Committee and for Prochaska to provide a cap amount for their services after the first or second meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Lorenzen and Hineline. Nay: Kruger. Motion carried.

Phil Lorenzen, DA Davidson & Co discussed updating previous engagement letters to be more current and specific as to possible projects and dates. Motion Kruger second Quist to update the previous engagement letter with Philip Lorenzen, DA Davidson & Co to include projects currently under discussion. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

VanderSchaaf discussed the Deputy County Attorneys being salaried employees and the record keeping on their paycheck stubs.

Chairman received information from the Jail Committee Chairman regarding the Citizens Advisory Committee and asked this be tabled until all Board members could review it. Motion Quist second Kruger to table issue of ground rules for Citizens Advisory Committee and the Jail Committee report. Vote- Aye: Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: Cerio & Kramer. Motion carried.

Board discussed computer upgrades for Courthouse equipment/servers. Steve Mencke, Assessor handed out information from Right Tech Computer Solutions. VanderSchaaf said the contract with James Overton, Lantex isn't finalized and handed out drafts of the contract showing the revisions. Motion Hineline second Cerio to table the contract with Overton until the next Board meeting and have VanderSchaaf contact Mr. Overton to discuss contract. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nav: None. Motion carried.

Hwy Supt Search Committee: Motion Kruger second Cerio to go into closed session for the prevention of needless injury to the reputation of an individual regarding salary negotiations for Highway Superintendent applicant. Vote- Aye: Cerio, Kramer, Quist, Kruger, Lorenzen and Hineline. Nay: None. Johnson absent. Motion carried. Chairman repeated the closed session was for the prevention of needless injury to the reputation of an individual regarding salary negotiations for Highway Superintendent applicant. Johnson was present. Board went into closed session at 5:35 PM. Motion Hineline second Kramer to come out of closed session at 5:48 PM. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. In open session, Chairman restated the closed session was for the prevention of needless injury to the reputation of an individual regarding salary negotiations for Highway Superintendent applicant. Motion Kruger second Hineline to have Committee offer this gentleman the Highway Superintendent position at the salary discussed in closed session. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Board discussed various legislative bills and had received email from Lydia Brasch thanking them for the letter of opposition to LB 958 (budget exceptions).

Committee Reports: Bldg & Grds- getting bids on heat tape, work is progressing on roof. Three Rivers Health Dept is having a seminar at Memorial Community Hospital.

There were no comments from the public.
