The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:35 a.m. on Tuesday, March 8, 2016 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Carl Lorenzen declared the meeting was in session and that the meeting is being recorded. Lorenzen made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman Carl Lorenzen, County Board Members, Paul Cerio, Mary Alice Johnson, Jeff Quist, Ron Hineline and Steven Kruger. Lisa Kramer was absent. Also present, County Clerk Merry Truhlsen and Co Atty Scott VanderSchaaf.

Motion Cerio second Hineline to approve agenda for Mar 8, 2016. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. It was moved by Cerio and seconded by Hineline that the rules be suspended and that the minutes of the Feb 23 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

It was moved by Cerio and seconded by Hineline that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$383, Reg of Deeds \$23,896, Co Court \$17,187, Co Plan Dept \$10,455, Clk Dist Crt \$1713, Sheriff \$2635 and Road Dept \$683; Feb. Treas Statement- Collections \$759,811; Disbursements \$1,088,624; Inheritance Tax \$187,302; Ending balance \$4,829,219. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

The following correspondence has been received: NIRMA's 2015 annual report, letter from Nebr Board of Engineers & Architects citing problems with Dennis Vodicka/Standard Bridge Co, Wash Co Extension Office Annual Report and letter from Lisa Kramer on Tech Committee. It was moved by Kruger and seconded by Quist that the correspondence be received and placed on file. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Road Foremen Bob Smith and Rollie Husk were present for Road Dept items: Smith gave an update on the on the County Road P26 bridge project, done by Dixon Construction, and said it is nearing completion.

Dan Norman, Civil Solutions, gave an update on the Co Road 5 & 6 box culverts. The project is 95% completed, grading work is done, roads are open and just the seeding and erosion control is left to do.

Kruger introduced William Hansel, the Search Committee's recommendation for Highway Superintendent. Hansel briefly went over his background and credentials. Motion Kruger second Cerio to hire William Hansel as the Washington County Highway Superintendent at an annual salary of \$68,000. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

VanderSchaaf told Board we did receive the inter-local agreement with Doug Co, City of Omaha and Wash Co for the USA Triathlon with the changes he requested. Chairman did sign the agreement and the plans for the triathlon are moving forward.

Motion Hineline second Quist to allow Blair Chamber of Commerce to use north Courthouse lawn for Gateway to the West craft and vendor show on June 11th. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Clerk discussed Resolution 2016-4, correcting the amount of money transferred to the STOP Program Fund #2356 from General Fund, on Resolution 2015-23. Motion Kruger second Johnson to adopt Resolution 2016-4. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Legal advice & possible negotiations regarding FOP Contract and possible Memorandum of Understanding (MOU) 3. Legal advice regarding Lantex contract. In open session motion Kruger second Quist on Item #1- take no action on the legal advice as it involves Tax Certificates regarding Parcel #890022148, 890022435, 890022155 and 890086880; on Item #2 Direct County Attorney to prepare a Memorandum of Understanding (MOU) for the FOP Contract and on Item #3 Discontinue negotiations with Lantex for failure to reach an agreeable contract. Vote- Aye: Cerio, Johnson, Quist, Kruger and Lorenzen. Hineline was absent. Nay: None. Motion carried.

Jon Mooberry, JEO Engineering, had a hand out for the Board with an updated opinion of cost for the Kennard SE (CR P32) Project at \$4,092,700. Mooberry went through 3 options for proceeding with this project and recommended Option 1, which would entail letting the culvert/grading project in the fall of 2016, with construction in 2017/2018, followed by a separate paving project. Board discussed the project and the estimated completion date of the Hwy 133 construction. Motion Hineline second Kruger to accept Option 1 and authorize JEO to finish engineering. Mooberry said he will bring a supplemental agreement for these changes to the next meeting. Vote- Aye: Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: Cerio. Motion carried.

Quist reviewed options for courthouse computers: Board already voted on discontinuing negotiations with James Overton, Lantex. Quist discussed some issues and costs involved in going to virtual machines and suggested having offices keep using pcs at this time. Quist and Steve Mencke, Co Assessor next discussed replacing the old outdated server by purchasing one through Dell Computers, using the State bid pricing. This server would house the real estate assessment/tax collection software and support programs used by the Assessor and Treasurer's offices and other programs. Quist next talked of 2 options for email service- have our email hosted through MIPS or purchase an exchange server from Dell. Mencke will have the state pricing for servers at next meeting. Motion Hineline second Cerio to table any action on servers until the next meeting. Vote- Aye: Cerio, Johnson, Quist, Lorenzen and Hineline. Nay: Kruger. Motion carried.

Cerio gave an update on forming the Jail Advisory Committee. Board, Co Atty and Sheriff Robinson discussed moving ahead as quickly as possible with the Committee meetings to discuss the future of the Washington County Jail. Motion Kruger second Quist to have Jail Advisory Committee come back to the Board with their recommendation/conclusion on or before August 23, 2016. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Board briefly discussed legislative bills. There were no comments from the public.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Quist that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.
