The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 4:13 p.m. on Tuesday, June 28, 2016, in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Carl Lorenzen declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Carl Lorenzen, County Board Members, Paul Cerio, Lisa Kramer, Mary Alice Johnson, Jeff Quist, Steven Kruger and Ronald Hineline. Also present, Deputy County Clerk Carol Kuhr and Co Attorney Scott VanderSchaaf.

Motion Kramer second Quist to approve agenda for June 28, 2016. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, Quist, and Kruger. Nay: None. Motion carried. It was moved by Kruger and seconded by Quist that the rules be suspended and that the minutes of the June 14, 2016, meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kramer, Johnson, Hineline, Quist, and Kruger. Nay: None. Lorenzen – Abstain. Motion carried.

Motion carried.

Motion by Cerio second by Hineline to open public hearing to vacate/abandon a portion of segment of road that is an extension to Maney Lane in Allen Hills Subdivision. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline Quist, and Kruger. Nay: None. Motion carried. Bill Hansel, County Road Superintendent discussed the road closure. There were no comments from the public. Motion by Kruger and second by Kramer to close public hearing. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline Quist, and Kruger. Nay: None. Motion carried. Deputy Clerk read resolution 2016-11. Motion by Kruger and second by Kramer to adopt Resolution 2016-11 vacating/abandoning proposed portion of Maney Lane in Allen Hills Subdivision. Stat. 39-1722, as amended, has been received from the Washington County Highway Superintendent recommending the vacation and abandonment of a portion of Segment of Road that is an extension to Maney Lane located in Allen Hills Subdivision. Northwest ¼ of Section 18, T17N, R12E, that runs between Lots 47 & 54 in said subdivision, in Washington County, Nebraska, more particularly described as Exhibit "A", which is attached with this resolution.

WHEREAS, The Washington County Board of Supervisors held a Public Hearing in regard to the vacation and abandonment of a portion of Segment of Road that is an extension to Maney Lane located in Allen Hills Subdivision, Northwest ¼ of Section 18, T17N, R12E, that runs between Lots 47 & 54 in said subdivision, in Washington County, Nebraska, said Public Hearing being held on Tuesday June 28, 2016 at 4:15 p.m. After the Public Hearing, the County Board deemed it to be in the best interest of the public that this Segment of Road, as included in the legal description, more particularly described as Exhibit "A", which is attached.

BE IT FURTHER RESOLVED THAT, the Washington County Board of Supervisors pursuant to Neb. Rev. State. 39-1722 does hereby vacate and abandon said portion of Segment of Road that is an extension to Maney Lane located in Allen Hills Subdivision. Northwest ¼ of Section 18, T17N, R12E, that runs between Lots 47 & 54 in said subdivision, in Washington County, Nebraska, and that ownership of said road shall revert to the property owner(s) of record at no cost to said owner(s). PASSED AND APPROVED THIS 28 DAY OF JUNE, 2016.

Hansel updated the Board on various road project. He discussed the yearly fees paid by Townships to the road department for maintenance were less than the expenses incurred. Board discussed rates with Township Board members. Motion by Kruger and second by Quist to leave the cost per mile at \$14.75 for the ensuing year. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, Quist, and Kruger. Nay: None. Motion carried.

Hansel stated that he was having difficulty getting rock from Martin Marietta and had been getting bids for hauling rock and obtaining rock from other companies. Board discussed alternate sources and costs of hauling. Motion by Hineline and second by Kruger to allow Road Superintendent to buy rock from alternate sources as needed while it cannot be supplied by Martin Marietta. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, Quist, and Kruger. Nay: None. Motion carried.

Kipp Kissinger, UNICO, updated the Board on the County group health insurance plan year and reported on premiums vs. claims through April 2016.

Lorenzen discussed a meeting with JEO representative regarding a \$25,000.00 reduction in current contracts. Motion by Johnson and second by Quist to send a letter to JEO stating claims will be withheld until a letter is received from JEO regarding procedure for the \$25,000.00 reduction in current contracts. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, Quist, and Kruger. Nay: None. Motion carried.

Chairman stated there would be a closed session in order to protect public interest whereby attorney/legal advice discussion will ensue with respect to litigation. Co Atty VanderSchaaf, Atty Pam Bourne and Board members were present. At 4:43, motion by Hineline and second by Kramer to go into closed session whereby attorney/legal advice discussion will ensue with respect to litigation. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, Quist, and Kruger. Nay: None. Motion carried. At 5:01, motion Kruger second Johnson to go out of closed session. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline Quist, and Kruger. Nay: None. Motion carried. Chairman restated that the closed session was in order to protect public interest whereby attorney/legal advice discussion ensued with respect to litigation. Dep Clerk Kuhr left the meeting, Clerk Merry Truhlsen was present. No action was taken in open session.

Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline and Quist. Nay: Kruger. Motion carried. Kruger stated he didn't think the agenda was sufficient and left the room. VanderSchaaf, Bourne and 6 Board members were present. Chairman stated the closed session was in order to prevent needless injury to an individual where by attorney/legal advice discussion will ensue. Motion Johnson second Kramer to come out of closed session 5:25. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, and Quist. Kruger was absent. Nay: None. Motion carried. In open session, motion Quist second Hineline to accept Planning & Zoning Administrator Tanna Wirtz's resignation as of September 2, 2016. Vote-Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline and Quist. Kruger abstained. Nay: None. Motion carried. Motion by Hineline second Quist to have Chairman appoint a committee to start a search for a new Planning and Zoning Administrator. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, Quist, and Kruger. Nay: None. Motion carried. Chairman appointed Kramer, Johnson and Hineline to the search committee.

Motion Quist second Cerio to go into a closed session, at 5:28, in order to protect public interest whereby attorney/legal advice discussion will ensue with respect to litigation. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, Quist, and Kruger. Nay: None. Motion carried. Co Atty and 7 Board members were present. Atty Stephen Kraviec was present to discuss his Child Support Enforcement Contract for August 1, 2016 through July 31, 2018. Kraviec has done child support enforcement for the County since Aug 2007. Kraviec received a letter from VanderSchaaf saying the Co Atty's office would be taking over these duties. Kraviec said he represents 7 counties and 90% of his business is child support enforcement. Kraviec provides this service for \$36,000 a year, which he believes is less than it would cost through the Co Atty's office. Hineline made a motion to table this, but then withdrew his motion. VanderSchaaf spoke of complaints he had received of people unable to contact Kraviec, a 32% compliance rate and other issues. Kraviec offered rebuttal and said he would get the compliance rate from the State. Motion Quist second Kruger to table this until the July 12th meeting. Vote-Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, Quist, and Kruger. Nay: None. Motion carried.

Gary Lambrecht discussed the fair and had applications for liquor licenses from the Ag Society and the Friends of the Fair who will be doing wine tasting on Aug 2. Clerk read Resolution 2016-13. Motion Kramer second Kruger to adopt Resolution 2016-13. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, Quist, and Kruger. Nay: None. Motion carried.
