The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:30 a.m. on Tuesday, Sept. 13, 2016 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Lorenzen declared the meeting was in session and that the meeting is being recorded. Lorenzen made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman Carl Lorenzen, County Board Members, Jeff Quist, Steven Kruger, Paul Cerio, Lisa Kramer, Mary Alice Johnson and Ron Hineline. Also present, County Clerk Merry Truhlsen and Co Atty Scott VanderSchaaf.

Chairman said there was a change on the agenda: item 2 under the Non-timed agenda items for a special designated liquor license, was cancelled. Motion Cerio second Hineline to approve revised agenda for September 13, 2016. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. It was moved by Cerio and seconded by Kruger that the rules be suspended and that the minutes of the August 23 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. The following correspondence had been received: Theresa Puls, Phelps Co Comm, is running for Sec/Treas on the NACO Board of Directors, Nebr State Historical Society has announced that the Gottsch Farmstead is listed on the National Register of Historic Places, letter from Sequoia Consulting Group requesting support of a bill, notice from Douglas Co Plan Comm of a special use permit application and letter from Bill Burdess protesting Board's decision on his property valuation protest. Motion carried. Burdess was present and read through the information.

Hwy Supt. Bill Hansel stated 2,100 tons of gravel and 700 tons of rock had been hauled in August. Hansel discussed progress on various road projects and discussed the roads after all the rain that has fallen. Hansel asked about getting a credit card for travel expenses and purchasing supplies. Co Atty said he has a purchase card from NACO (Nebr Assoc of County Officials). Motion Hineline second Kramer to allow Road Dept to apply for a NACO purchase card through US Bank. Hansel and Jon Mooberry, JEO engineer, discussed Ron Hineline's complaint on JEO Project 89BR16, Ft Calhoun NW Bridge. Co Atty advised against talking about liability at this time. Chairman asked this go back to the Rd Committee, appointing Quist to take Hineline's place on committee.
