The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 4:05 p.m. on Tuesday, September 27, 2016, in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Carl Lorenzen declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Carl Lorenzen, County Board Members, Paul Cerio, Lisa Kramer, Jeff Quist and Ronald Hineline. Mary Alice Johnson absent, but came in at 4:10. Steven Kruger absent. Also present, County Clerk Merry Truhlsen and Co Atty Scott VanderSchaaf.

Motion Cerio second Kramer to approve agenda for Sept 27, 2016. Vote- Aye: Cerio, Kramer, Quist, Lorenzen and Hineline. Johnson absent. Nay: None. Motion carried. It was moved by Hineline and seconded by Cerio that the rules be suspended and that the minutes of the Sept 13, 2016, meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kramer, Quist, Lorenzen and Hineline. Johnson absent. Nay: None. Motion carried.

The following correspondence has been received: NDOR Traffic crash facts, thank you from Duane Wilcox, info on NIRMA Board applicant Larry Cerny and NACO's legislative conference. It was moved by Cerio and seconded by Kramer that the correspondence be received and placed on file. Vote- Aye: Cerio, Kramer, Quist, Lorenzen and Hineline. Johnson absent. Nay: None. Motion carried.

Johnson was present. Merri Hightree, Deputy County Treasurer, gave the Board the annual report of delinquent taxes. Motion Quist second Hineline to receive, consider and review at the Oct 11th meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Lorenzen and Hineline. Nay: None. Motion carried.

Hwy Supt, Bill Hansel gave an update on road projects. Hansel discussed motorgrader bids. Quist said he talked to Bill Pook about the storm damage that occurred with the heavy rains. Hansel said he is still finding problems from the storm.

Hansel said the Road Committee discussed the reimbursement for motor grader operators, which is \$75 a quarter. Committee said they felt this amount should be increased in figuring hiring someone to repair the wear and tear on the driveway, cost of a load of rock and the cost of electricity. Motion Quist second Cerio to change the stipend for the motor grader operators to \$150 per quarter. Vote- Aye: Cerio, Kramer, Johnson, Quist, Lorenzen and Hineline. Nay: None. Motion carried.

Ryan Sullivan, Planning & Zoning Admin, discussed the general development plan of a proposed 10-lot residential subdivision, to be known as Homestead 77, from the NW¼SE¼ and Tax Lot 23, Section 6 Township 17 Range 12 (general location: Co. Rd. P35 north of Co. Rd. 32). Sullivan said the plans include accommodating a shire horse reserve. Board discussed various aspects of the subdivision.

Mike Smith, Weed Dept, discussed setting an administrative fee in addition to other costs for spraying weeds. Motion Hineline second Johnson to approve a \$75 administrative fee to property owners for the Weed Dept spraying weeds. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen and Hineline. Nay: Quist. Motion carried.

Board discussed renewing the Dodge County E911 interlocal agreement which the County has been a part of since 1992. Motion Hineline second Quist to authorize Chairman to sign Interlocal Agreement which will be in effect from Jan 2017 through Dec 2026. Vote- Aye: Cerio, Kramer, Johnson, Quist, Lorenzen and Hineline. Nay: None. Motion carried.

Motion Cerio second Johnson to go into a closed session at 4:58 pm in order to protect the public interest for the purpose of a legal strategy session concerning site selection whereby protected attorney client privilege discussion will ensue. Vote-Aye: Cerio, Kramer, Johnson, Quist, Lorenzen and Hineline. Nay: None. Motion carried. Chairman said the closed session is in order to protect the public interest for the purpose of a legal strategy session concerning site selection whereby protected attorney client privilege discussion will ensue. Those present for the closed session were 6 Board members, Sheriff Mike Robinson and

Co Atty VanderSchaaf. Motion Johnson second Kramer to go out of closed session at 5:28 pm. Vote- Aye: Cerio, Kramer, Johnson, Quist, Lorenzen and Hineline. Nay: None. Motion carried. Chairman restated the closed session was in order to protect the public interest for the purpose of a legal strategy session concerning site selection whereby protected attorney client privilege discussion will ensue. There was no action taken in open session.

Motion Kramer second Johnson to go into a closed session at 5:29 pm in order to protect the public interest for the purpose of a legal strategy session concerning possible surveying needed for litigation case. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen and Hineline. Quist absent. Nay: None. Motion carried. Chairman said the closed session is in order to protect the public interest for the purpose of a legal strategy session concerning possible surveying needed for litigation case. Those present for the closed session were 6 Board members, Co Atty and Hwy Supt Hansel. Motion Kramer second Johnson to go out of closed session at 5:48 pm. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Quist and Hineline. Nay: None. Motion carried. Chairman said the closed session was in order to protect the public interest for the purpose of a legal strategy session concerning possible surveying needed for litigation case. In open session, motion Hineline second Cerio to authorize Hwy Supt to hire a surveyor at a cost not to exceed \$2,000. Vote- Aye: Cerio, Kramer, Johnson, Quist, Lorenzen and Hineline. Nay: None. Motion carried.

Committee reports were heard from Road, Region 6, Bldg & Grounds and Technology. There were no comments from public.

Claims were received and reviewed, following which it was moved by Quist and seconded by Cerio that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Cerio, Kramer, Johnson, Quist, Lorenzen and Hineline. Nay: None. Motion carried.
