The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 4:00 p.m. on Tuesday, October 25, 2016, in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Carl Lorenzen declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Carl Lorenzen, County Board Members, Paul Cerio, Lisa Kramer, Mary Alice Johnson, Jeff Quist, Steven Kruger and Ronald Hineline. Also present, County Clerk Merry Truhlsen and Co Atty Scott VanderSchaaf. There was no Board of Equalization.

Motion Quist second Hineline to approve agenda for Oct 25, 2016. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. It was moved by Hineline and seconded by Kramer that the rules be suspended and that the minutes of the Oct 11, 2016, meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kramer, Quist, Kruger, Lorenzen and Hineline. Nay: None. Johnson abstained. Motion carried. There was no correspondence.

Hwy Supt, gave an update on road projects and said the bid letting for Co Rd 4 is Nov 22.

Hansel had received a request from the State for a sales tax form to be included in the annual reports. Motion Quist second Hineline to authorize Chairman to sign the form for the Road Dept Annual Reports at the State's request. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Four bids were received for financing on motor graders. Hansel opened the following bids and read the interest rates: Washington County Bank- interest rate 2.35%; Two Rivers Bank- 2.35%; US Bank Equipment Finance, Inc- 2.34% and Nebraska Machinery Company-2.49%. Hansel said he would like time to read the bids more thoroughly. Motion Hineline second Cerio to table approving financing for motor graders until the Nov 7th meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Kruger discussed information he gave to the Board regarding the recent motor grader bids and the trade ins.

Phil Lorenzen, DA Davidson, discussed updating the engagement letter with DA Davidson to be in compliance with the SEC. Motion Quist second Kruger to update the DA Davidson underwriting engagement letter to add additional language relevant to this current project of the rural road improvement districts. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Phil Lorenzen, DA Davidson, discussed information with the Washington County Board of Supervisors regarding the formation of rural road improvements districts pursuant to the Rural Road Improvement District Act, Sections 39-1638 through 39-1655, Reissue Revised Statutes of Nebraska, 2008, for the improvement of: (A) County Road 4 (also known as the "Scribner-Herman Road") from the Western County Line of Washington County, east a distance of approximately 7 miles to the east right-of-way line of County Road 15, Washington County, Nebraska to be designated "Rural Road Improvement District No. 2016-1"; and (B) County Road 32 from its intersection with Nebraska State Highway 133 east a distance of approximately 2 miles to its connection with the currently paved section of said County Road 32/County Road P32 (approximately 910 feet west of the center line extended south of County Road 35) Washington County, Nebraska, to be designated "Rural Road Improvement District No. 2016-2". The report of the County's special engineers, SCHEMMER, Architects|Engineers|Planners, Omaha, Nebraska, describes the scope of the improvements in Rural Road Improvement District No. 2016-1 as consisting of grading and construction of concrete pavement, storm sewer drainage structures including box culverts, concrete and metal culverts, surface drainage ways and improvements and other necessary and appurtenant improvements, the construction cost of which improvements is estimated to total \$4,695,954.56, excluding engineering, testing and miscellaneous costs. The report of the County's special engineers, JEO Consulting Group, Inc., Wahoo, Nebraska, describes the scope of the improvements in Rural Road Improvement District No. 2016-2 as the improvement of County Road 32 from its intersection with Nebraska State Highway 133 east a distance of approximately 2 miles to its connection with the currently paved section of said County Road

32/County Road P32 (approximately 910 feet west of the center line extended south of County Road 35) Washington County, Nebraska, said improvements in Rural Road Improvement District No. 2016-2 are described as Phase I, consisting of excavation, embankment fill, grading, guardrail, aggregate surfacing, and construction of storm water drainage structures including box culverts, concrete and metal culverts, surface drainage ways, and other necessary and appurtenant improvements. the construction cost of which Phase I improvements is estimated to total \$3,340,000, excluding engineering, testing and miscellaneous; and Phase II, consisting of removal of existing aggregate surfacing, subgrade preparation, shoulder construction and grading, and construction of concrete pavement, and other necessary and appurtenant improvements, the cost of which Phase II improvements is estimated to total \$2,020,000, excluding engineering, testing and miscellaneous costs. Board considered Resolution No. 2016-20 approving the form of and directing publication of Proposed Resolution No. 2016-21, for the creation of Rural Road Improvement District No. 2016-1 (County Road 4) of Washington County, Nebraska and setting a hearing date for said creation on November 22, 2016. Board had received copies of Resolutions 2016-20 and 2016-22, Chairman asked if Board wanted them read or wanted to waive reading. Motion Quist second Hineline to waive the reading of Resolution 2016-20. Vote-Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: Kramer. Motion carried. After further discussion of the matter, Supervisor Hineline moved the adoption of Resolution No. 2016-20, which motion was seconded by Supervisor Kruger. Vote-Aye: Kramer, Quist, Kruger, Lorenzen and Hineline. Nay: Cerio and Johnson. Motion carried.
