The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:38 a.m. on Monday, Nov 7, 2016 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Lorenzen declared the meeting was in session and that the meeting is being recorded. Lorenzen made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman Carl Lorenzen, County Board Members, Paul Cerio, Lisa Kramer, Mary Alice Johnson, Ron Hineline and Steven Kruger. Jeff Quist absent. Also present, County Clerk Merry Truhlsen.

Motion Kruger second Hineline to approve agenda for November 7, 2016. Vote- Aye: Cerio, Kramer, Johnson, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. It was moved by Hineline and seconded by Kruger that the rules be suspended and that the minutes of the October 25 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kramer, Johnson, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

It was moved by Hineline and seconded by Cerio that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$545, Reg of Deeds \$33,177, Co Court \$15,088, Co Plan Dept \$16,578; Clk Dist Crt \$2419, Sheriff \$2,910 and Road Dept \$240; October Treas Statement- Collections \$497,081; Disbursements \$1,153,841; Inheritance Tax \$647,144; Ending balance \$7,086,072. Bill Hansel, Hwy Supt, reported 1,500 ton of gravel and 500 ton of rock were hauled in October. Hansel gave a brief update on road projects. Hansel discussed the financing for 2 motor graders. Motion Kruger second Cerio to table approving financing until amoritization schedules from the financial institutions are received. Vote- Aye: Cerio, Kramer, Johnson, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Motion Kruger second Hineline to receive a statement from Marj Hoier, Co Treasurer, stating the 2015 and prior Distress Warrants were turned over to Washington County Sheriff on November 1, 2016. Vote- Aye: Cerio, Kramer, Johnson, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Clerk read Resolution 2016-23 adopting the Washington County Personnel Manual. Motion Johnson second Hineline to adopt Resolution 2016-23. Vote- Aye: Cerio, Kramer, Johnson, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

AT 9:00 AM a large group of citizens attended the Board meeting to discuss a proposed site for a County Jail. Glenn Uffelmann had a petition signed by 170 land owners and read from the petition which, among other things, requested the County Board cease all efforts to purchase Parcel ID #890019299 (parcel of Dana College property). Uffelmann said he knows the Board has a lot of tough decisions and problems to deal with and discussed reasons they feel this is not a good site for the Jail. Other people speaking regarding problems with the proposed site were: Barbara Franko Chapman, Bill Wardell, Milt and Jane Heinrich, Dennis McCormick and Sandra Wigdahl. Board discussed the information. Motion Kruger second Cerio to receive the petition and place on file. Vote- Aye: Cerio, Kramer, Johnson, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. Board thanked them for coming.

Board continued with Committee Reports: Chairman said the Jail subcommittee met with Prochaska and asked for the cost of a Jail Facility without courtrooms/court offices but haven't received any figures. Sheriff Mike Robinson asked to be included in any meetings where a change of plans is discussed. Bill Burdess asked about the cost of the jail facility.

Claims were received and reviewed, following which it was moved by Hineline and seconded by Kruger that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Cerio, Kramer, Johnson, Kruger, Lorenzen and Hineline. Nay: None. Motion carried
