The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:30 a.m. on Tuesday, Dec 13, 2016 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Lorenzen declared the meeting was in session and that the meeting is being recorded. Lorenzen made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman Carl Lorenzen, County Board Members, Paul Cerio, Lisa Kramer, Mary Alice Johnson, Ron Hineline, Jeff Quist and Steven Kruger. Also present, Deputy County Clerk Carol Kuhr and County Attorney Scott VanderSchaaf.

Chairman spoke regarding the Open Meetings Act and the County Board of Supervisors' meeting agenda. He requested the County Attorney to address each agenda item individually. VanderSchaaf responded he could. Chairman asked the board to address and review each individual item on the agenda.

VanderSchaaf spoke regarding the Open Meetings Act and items on the agenda not being specific causing violations of the Open Meetings Act. He stated the Board should not approve the agenda to include those items as it would cause the rest of the items on the agenda to be void. Board held discussion on the agenda as presented. Motion by Kramer and second by Cerio to remove agenda items 1-5 on the Washington County Jail as follows:

- 1. Disc/PA: Jail Site Greenfield locations to include the Dana College Site, OPPD Fort Calhoun Nuclear Station, City of Blair Property adjacent to the USDA Facility, Property East of USDA Facility, Jim Olson Property, Brent Arp Property, Rand Lauritsen Property and the Stratbucker Farms Property.
- 2. Discuss/PA: Citizen's Advisory Committee Recommendation which was received by the Washington County Board of Supervisors and placed on file for consideration. The Advisory Committee recommended selection of a Greenfield Site for a Criminal Justice Center and Law Enforcement Center.
- 3. Discuss/PA: Alternative Jail Site location to include existing Washington County Court House location.
- 4. Discuss/PA: All Options outlined in the Prochaska Jail Needs Assessment which include; Status Quo, Transporting Prisoners, Building a Law Enforcement Center on the current location, building a Criminal Justice Center and Law Enforcement Center and extensive remodeling of the Court House Court Rooms on the current location or selecting a Greenfield Site.
- 5. Disc/PA: Payment to be made in full for 3 invoices submitted by Prochaska & Associates on Phase 4 of the Prochaska Jail Needs Assessment Study during the Citizen's Advisory Committee review.

and items 6 and 7 on the Road agenda as follows: . 6. D/PA, pickup for road dept. 7. D/PA, 1 ton truck for road dept. Board held further discussion on agenda items. County Attorney stated he had no problem with the rest of the items on the agenda once these were removed. Motion by Kruger to end discussion on the original motion. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, Quist, and Kruger. Nay: None. Motion carried. Vote on original motion to remove agenda items 1-5 on the Washington County Jail and items 6 & 7 on the Road Department: Aye: Cerio, Kramer, Johnson, and Kruger. Nay: Lorenzen, Hineline, and Quist. Motion carried. Motion by Kruger and by second Cerio to approve agenda for December 13, 2016 with the designated items removed. Aye: Cerio, Kramer, Johnson, and Kruger. Nay: Lorenzen, Hineline, and Quist. Motion carried

It was moved by Kruger and seconded by Cerio that the rules be suspended and that the minutes of the November 22 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Quist, and Kruger. Nay: Hineline. Motion carried.

It was moved by Kruger and seconded by Cerio that the regular monthly fee reports of the following officials be received and placed on file: County Clerk \$104, Register of Deeds \$41,903, County Court \$19,921, County Planning Dept \$14,254; Clerk District Court \$1,297, Sheriff \$1,626 and Road Dept \$93,896; November Treasurer's Statement- Collections \$482,178; Disbursements \$1,463,064; Inheritance Tax \$116,313; Ending balance \$6,105,186. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, Quist, and Kruger. Nay: None. Motion carried

There was no correspondence received by the County Clerk prior to the meeting. Kramer read into record a letter received from

Washington County Sheriff, Mike Robinson on December 12, 2016, regarding the jail site selection. Lorenzen stated that the letter was not sent to the Site Selection Committee. It was moved by Kramer and seconded by Cerio that the correspondence be received and placed on file. Vote- Aye: Cerio, Kramer, Johnson, and Quist. Nay: Kruger, Hineline, and Lorenzen. Motion carried

Lisa Scheve, Director, Gateway Development Corporation, was present and gave the Board third quarter updates on employment figures and prospective projects for Washington County.

Bill Pook, Region 5/6 Emergency Management, discussed the annual letter of agreement between Washington County, Region 5/6, OPPD and the Ft. Calhoun Nuclear Storage Facility. No changes were made to the previous years' agreement. Motion by Kruger and second by Kramer to approve the annual letter of agreement between Washington County, Region 5/6, OPPD and the Ft. Calhoun Nuclear Storage Facility and give the Chairman authorization to sign it. Vote- Aye: Cerio, Kramer, Johnson, Lorenzen, Hineline, Quist, and Kruger. Nay: None. Motion carried.

Bill Hansel, Highway Superintendent was present for awarding the bid for County Road 4 project, Resolution 2016- 32. Bids had been received and opened at the previous Board meeting. Hansel and Shane Swope with Shemmer and Assoc. discussed the previous work of companies that had bid and also addressed concerns about County Road 4. Jason Aschoff with A&R Construction answered questions from the Board. Motion by Kruger and second by Cerio to follow the Road Committee's recommendation to accept the bid of A&R Construction of Plainview, Nebraska, in the amount of \$3,048,065.64 with a construction and completion date from June to September of 2017 and adopt resolution 2016-32. Deputy Clerk read resolution. Vote- Aye: Cerio, Kramer, Lorenzen, Hineline, and Kruger. Nay: Quist and Johnson. Motion carried.

Board and Technology Committee discussed a previously tabled item regarding payment to Right Tech Solutions for a virtual server. Motion by Kruger and second by Hineline to accept the bid on Right Tech quote 1265 in the amount of \$3,588.00 to replace existing WASHINGTON (2003) server with virtual server 2012R2. Ryan Sullivan, Planning and Zoning Administrator spoke with the Board regarding the renewal of the Inter-local Agreement between Blair City and Washington County for Building Inspector. Lorenzen and Quist-Jail Site Selection Committee reviewed the jail greenfield site locations to include the OPPD Fort Calhoun Nuclear Station, Dana College site, James Olson property, Rand Lauritsen property, Miller property, USDA, Stratbucker Farms property, Brent Arp property, Lane Rogers property, and East Grant Street property. These were either not viable choices or unavailable for building the jail. Dennis McCormick stated that the Jim Olson property should be listed as Tim Olson being the owner.

Chairman acknowledged the correction. The committee opinion is that there is no viable property for a greenfield site. Board opened discussion. Dan Flynn from the Jail Citizens Advisory Committee, Barbara Franco Chapman, and Hillary Rosencrants discussed the jail site selection with the Board.
