February 14, 2017 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:30 a.m. on Tuesday, Feb 14, 2017 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Lorenzen declared the meeting was in session and that the meeting is being recorded. Lorenzen made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Carl Lorenzen, County Board Members, Steve Dethlefs, Lisa Kramer, Bob Frahm, Andy Andreasen, Steven Kruger and Jay Anderson. Also present, County Clerk Merry Truhlsen and Co Atty Scott VanderSchaaf.

Motion Kruger second Andreasen to approve agenda for February 14, 2017 with the following change: that the Closed Session be moved to precede Jail Committee meeting report. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. It was moved by Kruger and seconded by Anderson that the rules be suspended and that the minutes of the January 24 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

It was moved by Kruger and seconded by Andreasen that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$467, Reg of Deeds \$26,553, Co Court \$12,914, Co Plan Dept \$15,206; Clk Dist Crt \$3,426, Sheriff \$1,536 and Road Dept \$28973; January Treas Statement- Collections \$842,194; Disbursements \$979,346; Inheritance Tax \$120,673; Ending balance \$6,292,596. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. There was no correspondence.

Bill Hansel, Hwy Supt, gave an update on CR34 reconstruction and CR7 box culvert (Arlington Northwest). Rock hauled last month was almost 1,000 ton, gravel was 900 ton.

Board discussed the agreement between Washington County and OPPD for the Arlington Northwest road project. Co Atty had reviewed the document. Motion Kruger second Kramer to have Chairman sign agreement. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Hansel discussed purchasing a new motor grader and dump truck, with trade ins of a 2012 JD motor grader and a 2009 International. Board discussed the purchases. Mike Andersen spoke. Motion Kruger second Anderson to authorize Hwy Supt Hansel to purchase 1 dump truck and 1 motor grader by using the state bid or other bid process. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Kruger discussed testifying on Legislative Bills 55 and 584 both dealing with roadside mowing. Hansel discussed LB 310 regarding bridges and some possible costs to the County to provide signage for bridges.

Tracey Behnken, Extension Educator, discussed the revisions the Extension Board made recently to their Constitution and Bylaws, which had not been updated since 1997. Motion Kruger second Kramer to concur with Extension Board to approve the revised Constituion and Bylaws and authorize Chairman to sign. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

County Planning and Zoning item: REZONE 1. Request by Barry Kolterman-Rezone of a proposed residential subdivision, to be known as Homestead 77, from the NW ¼ SE ¼ and Tax Lot 23, Section 6 Township 17 North-Range 12 East of the Sixth P.M. (general location: Co. Rd. P35 north of Co. Rd. 32) from A-1 primary agricultural to RS-2 and RA as per subdivision regulations. Motion Kramer second Kruger to open a public hearing. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. There were no public comments. Motion Kruger second Kramer to close the public hearing. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. Motion Kruger second Andreasen concur with Planning Commission to approve the rezone request as presented. Vote-Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Andy Andreasen submitted a proposed contract between Andy's Mow Town Inc and Washington County to allow for continued as needed services of equipment and repairs with the Washington County Roads, Weed and Grounds departments. Andreasen also submitted a Contractual Interest Statement, Form C-3, from the Nebr Accountability and Disclosure Commission, to comply with disclosure requirements. Motion Kruger second Kramer to approve contract and authorize Chairman to sign. Vote-Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. Form C-3 will be placed on file at the County Clerk's office.

In accordance with Statute 23-1608, the County Board hired the CPA firm of Ritterbush & Piotrowski to perform a complete and comprehensive annual audit of the books, accounts and records of all County Officers. Board discussed the audit. Phil Lorenzen, DA Davidson, spoke. Motion Kruger second Andreasen to receive and place on file the Washington County audit from Ritterbusch & Piotrowski through June 30, 2016. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. The audit report is on file at the County Clerk's office.

Several Officials were present as Andreasen continued discussion from 1/24 on changing Board meeting times. Marj Hoier, Merri Hightree, Bill Hansel, Mike Andersen, Jeff Quist, Jane Heinrich and Steve Mencke spoke. Motion Andreasen second Dethlefs to change Board meeting times in March to 3:00 PM. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Alan Kohll, Director, Race Omaha, discussed the USA Triathlon event in August 2017, which includes areas in southeast Washington County. Kohll said they are estimating 5,000 participants. The County entered into a two year agreement in 2016. VanderSchaaf said he will work with Douglas County to get the interlocal agreement in place.

Susan Paulsen, Clerk of District Crt, discussed LB 544 relating to clerks of the district court. Paulsen is testifying tomorrow in opposition to the bill. Motion Kruger second Anderson to authorize Chairman to sign a letter of opposition on LB 544. Vote-Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Motion Dethlefs second Kramer to go into closed session at 10:28 am to protect the public interest whereby discussion will be had regarding potential anonymous donor and parameters of said donation for law enforcement center. Vote- Aye: Dethlefs, Kramer, Frahm and Anderson. Nay: Kruger, Lorenzen and Andreasen. Motion carried. Kruger said he opposes the closed session and won't stay. Dennis McCormick spoke against the closed session. Chairman stated the reason for the closed session was to protect the public interest whereby discussion will be had regarding potential anonymous donor and parameters of said donation for law enforcement center. Those present for the closed session were 6 Board members, Sheriff Robinson, Chief Deputy Willis and Co Atty VanderSchaaf. Motion Andreasen second Anderson to go out of closed session at 10:54 am. Vote-Aye: Dethlefs, Kramer, Frahm, Anderson, Lorenzen and Andreasen. Kruger absent. Motion carried. In open session Chairman restated the reason for the closed session was to protect the public interest whereby discussion was had regarding potential anonymous donor and parameters of said donation for law enforcement center. There was no action taken.

Jay Anderson discussed the Jail Committee meeting and the Co Atty's recommendation to reaffirm the Prochaska & Assoc, Amendment to Phase 4 dated 6/22/16. Motion Anderson second Kramer to (re) affirm Washington County's (hereinafter WC) responsibilities as stated in the Prochaska & Associates (hereinafter P&A) June 22, 2016 Amendment letter (with attachments), Amended Paragraph "C", specifically: C. WC RESPONSIBILITIES- WC agrees to negotiate and enter into an AIA Owner/Architect Agreement with P&A for design and construction phase services for the proposed Washington County Law Enforcement Center, contingent upon successful financing of the project. Vote- Aye: Dethlefs, Kramer, Frahm, Andreasen and Anderson. Nay: Kruger and Lorenzen. Motion carried. Kruger and Lorenzen stated the Amendment dated 6/22/16 is already in place, there is no need to vote on it again. Board discussed the motion. VanderSchaaf and Mike Andersen spoke.

Carl Lorenzen discussed information regarding property for sale as a possible site for the Law Enforcement/Criminal Justice Center. Kruger said to have something to discuss, he made a motion to look at the Courthouse grounds to see if a 75 bed LE/CJC would fit on the current site. Sheriff Robinson said it's hard to know without having plans drawn up. Motion Dethlefs second Kramer to table indefinitely Kruger's motion, but as there was no second on the first motion, Dethlefs said his motion was not relevant. Lorenzen made a motion, seconded by Andreasen to enter into good faith negotiations with Prochaska and Assoc, for the design phase of a new Wash Co LE/CJC on a site to be determined by the Wash Co Supervisors. Negotiations will be conducted by a negotiating committee representing Wash Co and Prochaska & Assoc. Wash Co negotiating committee members will be appointed by the Wash Co Board Chairman. Kramer objected to the Chairman making a motion. The motion was discussed. Vote- Aye: Lorenzen and Kruger. Nay: Dethlefs, Kramer, Frahm, Lorenzen and Anderson. Motion did not carry. Motion by Andreasen, second by Kruger, to move forward with Prochaska & Assoc to negotiate a contract and look at designing a 75 bed facility on the north side of the Courthouse, working with the Jail Committee and bring it back to the Board for a vote, and if at that time this plan doesn't work, to more forward to an alternate site. Motion was discussed. Andreasen asked if he could withdraw his motion and restate it, Kruger agreed to withdraw his second. Discussion continued. Motion by Andreasen

second by Anderson, to enter into good faith negotiations with Prochaska and Assoc, for the design phase of a new LE/CJC to be placed at a location yet to be determined by the Wash Co Board of Supervisors. Negotiations to be conducted by the Jail Committee and Prochaska & Assoc, and will be brought forward to the Board for approval. Motion was discussed. Vote-Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. McCormick, VanderSchaaf, Mike Andersen, William Burdess, Jeff Quist, Don Prochaska, Milt Heinrich, Glenn Uffelmann and Phil Lorenzen spoke.

Board discussed financing options for a potential new Law Enforcement and Criminal Justice Center under NRS §23-120. Phil Lorenzen, DA Davidson, said as the Board determines the best long term solution and comes to consensus; they can then determine what is possible financially. Phil talked of statute limitations for County borrowing. No action was taken.

Anderson discussed testifying on LB390, regarding the Papio NRD bonding authority.

Committee Reports – Rd Comm- Kruger emailed minutes, Bldg & Grds-Andreasen said the boiler is installed and key cards are in use, Dethlefs said he met with Ft Atkinson Comm and the Joint Co Brd/Plan Comm about the Comp Plan, Kramer discussed replacements for Region 6 board.

Comments from public – McCormick said it's good to have an agreement on the jail.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Andreasen that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.
