The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:00 p.m. on Tuesday, March 14, 2017 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Lorenzen declared the meeting was in session and that the meeting is being recorded. Lorenzen made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Carl Lorenzen, County Board Members, Steve Dethlefs, Lisa Kramer, Bob Frahm, Andy Andreasen, Steven Kruger and Jay Anderson. Also present, County Clerk Merry Truhlsen and Deputy County Attorney Emily Beamis. There was no Board of Equalization.

Motion Kruger second Kramer to approve the agenda for March 14, 2017 and that the rules be suspended and that the minutes of the February 28 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

It was moved by Kruger and seconded by Andreasen that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$363, Reg of Deeds \$15,317, Co Court \$17,250, Co Plan Dept \$18,621; Clk Dist Crt \$5,140, Sheriff \$2,380 and Road Dept \$1,190; February Treas Statement- Collections \$517,910; Disbursements \$858,085; Inheritance Tax \$131,113; Ending balance \$5,952,422. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

The following correspondence had been received: Nebr Dept of Roads District 2 Program Hearing and evaluation by Insurance Services Office (ISO) in April. It was moved by Kruger and seconded by Kramer that the correspondence be received and placed on file. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Marj Hoier, Co Treasurer, discussed the tax sale where 47 bidders purchased 60 tax sales for \$231,247.16. Motion Kruger second Kramer to receive the report of 2017 Tax Sale held on March 6, 2017 and place on file. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Road Chairman Kruger went over Road Dept items as Bill Hansel, Hwy Supt, was absent. Kruger reported some items discussed at the Road Committee meeting were motor graders, project updates, mowing requirements, procedure for cleaning a ditch and gravel. Kruger went on to discuss a contract with Schemmer Associates Inc on County Road 4 improvements to render construction management and inspection services for an estimated fee of \$130,356. Co Atty has reviewed the contract. Motion Kruger second Andreasen to authorize Chairman sign the contract with Schemmer on CR4. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. Kruger next discussed right of way agreements in connection with Project C008902120, a box culvert on CR21 north of Hwy 30. Tract 1 was with 711 Holdings LLC and Tract 2 was with Kevin & Pamela Arp. Motion Kruger second Andreasen to have Chairman sign ROW documents for Project C008902120. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Board discussed a proposal from Ric Ortmeier, CPA, to assist in the Wash Co budget preparation. Chairman discussed the fee is based on hourly rate of \$150 to \$210, which if charges approach \$3,600 Ortmeier will discuss the additional time required. Motion Kruger second Frahm to hire Ric Ortmeier to assist with the County budget preparation. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Chairman discussed submitting agenda items to the Clerk by 4:30 PM on the Thurs preceding the County Board meeting, realizing this will not always be possible. Board discussed the advantages of having more time to have questions answered and to post agenda on the website. Kramer disagreed saying that submitting items on the day before the meeting worked better for her schedule. Motion Andreasen second Anderson to submit agenda items by Thurs preceding meeting at 4:30. Vote- Aye: Dethlefs, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: Kramer. Motion carried.

Board briefly commented on legislative bills.

Committee Reports – Anderson attended an NRD open house in Blair; Kramer said the Tech Comm met, sent a survey to offices and went to Region 6 meeting; Kruger went to Gateway meeting. Lorenzen established a new committee- Washington County By-Laws/Board Meeting Policies Committee made up of Dethlefs, Anderson and Frahm, with the purpose to draft a set of bylaws or meeting policies for the Board.

There were no comments from the public.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Frahm that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.
