The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:05 p.m. on Tuesday, May 23, 2017, in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Temporary Chairman Kruger declared the meeting for May 23, 2017 was in session and that the meeting is being recorded. Open Meetings Law is posted on the door and the north wall. Present: County Board Members, Lisa Kramer, Bob Frahm, Steven Kruger, Andy Andreasen and Jay Anderson. Absent: Steve Dethlefs and Carl Lorenzen. Also present, County Clerk Merry Truhlsen, Co Atty Scott VanderSchaaf and Sheriff Mike Robinson.

Motion Kramer second Anderson to approve agenda for May 23, 2017. Vote- Aye: Kramer, Frahm, Kruger, Andreasen and Anderson. Nay: None. Motion carried. It was moved by Kramer and seconded by Andreasen that the rules be suspended and that the minutes of the May 9, 2017, meeting be approved and that minutes will not be read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Kramer, Frahm, Kruger, Andreasen and Anderson. Nay: None. Motion carried. The following correspondence has been received: 2nd Quarter Report from Extension Office. It was moved by Kramer that the correspondence be received and placed on file. Vote- Aye: Kramer, Frahm, Kruger, Andreasen and Anderson. Nay: None. Motion carried. Nay: None. Motion carried.

Hwy Supt. Bill Hansel discussed having Speece Lewis Engineering do the engineering on several projects so they are ready to go when funding is available. Board discussed the projects. Motion Kramer second Anderson to approve entering into contracts with Speece Lewis Engineering on: 1. Project C-89 (358) Bridge; 2. Project C-89 (584) Bridge; 3. Project C-89 (609) Culvert; 4. Project C-89 (610) Culvert; 5. Project C-89 (611) Culvert. Vote- Aye: Kramer, Frahm, Kruger, Andreasen and Anderson. Nay: None. Motion carried.

At 3:15 PM Board received 1 striping bid. Hansel read the bid from Midwest Striping Co for \$14.96 per gallon applied. Hansel said he has approximately 50 miles to stripe, but the number may change. Board discussed the bid. Motion Anderson second Kramer to table the striping bid from Midwest Striping until a more defined breakout on total costs for striping is presented. Vote- Aye: Kramer, Frahm, Andreasen and Anderson. Nay: Kruger. Motion carried. This will be put on the June 13 agenda.

Hansel gave an update on Road Dept projects and training.

At 3:30 PM the Board received one sealed bid for the sale of the following County owned property: TL23, Section 18-18-12. John Archer submitted a bid for \$1,000. Kruger said Kaiser Appraisal Services had completed an appraisal on the property and listed the value as \$1,000. Motion Frahm second Anderson to accept the bid received from John Archer to purchase TL23 Sec 18-18-12 for \$1,000. Vote- Aye: Kramer, Frahm, Kruger, Andreasen and Anderson. Nay: None. Motion carried.

Ryan Sullivan, Planning and Zoning Administrator had the following public hearings:

1. Conditional Use Permit: Farmers Union Co-op Association requests a CUP for storage and delivery of anhydrous ammonia and dry bulk fertilizer on premises. CUP to include one (1) unlit business sign. Legal description: Tax Lot 6 in Section 35 Township 17 Range 10. Location: 1366 Co Rd 19, Bennington. Planning Commission approved the CUP request with truck signage (2 signs- trucks entering and exiting) and a review in 25 years. Chairman opened a public hearing. Sullivan discussed the CUP. Working with Sullivan, Hwy Supt Hansel had Tim Farmer, Speece Lewis Engineers, out to the area and Farmer did recommend a turn lane. Hansel discussed the criteria for a turn lane mentioning sight distance and ADT (average daily traffic). Loren Katt, Farmers Union Co-op Assoc manager, discussed the Co-op's proposal, saying they will move the driveway to the north to eliminate the sight distance problem. Katt said this is a seasonal business and will be operational for 2 months in the spring and 2 months in the fall. Co Atty VanderSchaaf asked Board to take the engineer's recommendation under advisement. Jerry O'Stransky, Co-op Board President, spoke. Board discussed the information. Chairman closed public hearing. Motion Anderson second Andreasen to concur with Planning Commission recommendation to approve CUP for storage and delivery of anhydrous ammonia and dry bulk fertilizer on premises, CUP to include one (1) unlit business sign, truck signage and a review in 25 years, TL 6 Section 35-T17-R10, 1366 Co Rd 19, Bennington. Vote- Aye: Kramer, Frahm, Andreasen and Anderson. Nay: Kruger. Motion carried.

2. Rezone: Farmers Union Co-op Association requests to have parcel rezoned from A-1 Primary Agriculture to A-2 Commercial Agriculture. Legal description: Tax Lot 6 Section 35 Township 17 Range 10. Chairman opened public hearing. Sullivan discussed rezoning the parcel. Chairman closed public hearing. Motion Anderson second Andreasen to concur with Planning Commission and approve Rezone from A-1 Primary Agriculture to A-2 Commercial Agriculture for TL6 Sec 35-17-10 as presented. Vote- Aye: Kramer, Frahm, Kruger, Andreasen and Anderson. Nay: None. Motion carried.

3. Conditional Use Permit: Joyce Sallach of CSM Enterprises, LLC request for Conditional Use Permit to operate an RV Park Complex. Legal description: Tax Lot 48 in Section 28, Township 17 North, Range 13. & Tax Lot 15 in Section 27, Township 17 North, Range 13 East of the Sixth P.M. Location: 2164 Co. Rd. P51, Omaha. Planning Commission approved the CUP for an RV Park Complex with 80 spaces, a convenience store and marina to meet all County and floodplain regulations to include properly sized sewage disposal and dump stations with a 20 year review. Chairman opened the public hearing. Sullivan discussed the conditional use permit and stated owners are working on complying with list of requirements from Kris Robinson Building Inspector. Owners Monica Mitchell and Joyce Sallach discussed the property. Sheriff Robinson stated there has not been an issue with access. Chairman closed the public hearing. Motion Anderson second Frahm to concur with Planning Commission motion to approve CUP to operate an RV Park Complex in TL 48 Sec 28-T17-R13 & TL 15 Sec 27-T17-R13, 2164 Co. Rd. P51, Omaha, as presented. Vote- Aye: Kramer, Frahm, Kruger, Andreasen and Anderson. Nay: None. Motion carried.

Chairman opened a Public Hearing on Amending the 2016-2017 Budget and said this amended budget increases the Hi-Way Safety Grant Fund 2980 overtime expenditure amount by \$20,700, for a fund total of \$70,000. Grant money was received so there are no changes to the proposed tax request amount or County levy. Board discussed the changes. There was no public comment. Chairman closed public hearing. Motion Andreasen second Kramer to adopt Resolution 2017-5 adopting the 2016-2017 Amended Budget. Vote- Aye: Kramer, Frahm, Kruger, Andreasen and Anderson. Nay: None. Motion carried.
