August 22, 2017 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met to review department budgets at 1:00 p.m. on Tuesday, August 22, 2017, in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Lorenzen declared the meeting for August 22, 2017 was in session and that the meeting is being recorded. Lorenzen made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Carl Lorenzen, County Board Members, Steve Dethlefs, Lisa Kramer, Bob Frahm, Andy Andreasen, Jay Anderson and Steven Kruger. Also present, County Clerk Merry Truhlsen, Co Atty Scott VanderSchaaf and Sheriff Mike Robinson.

County Attorney discussed adding 2 emergency items to the agenda: 1. County Attorney requests the Co Atty Annual Subgrant Agreement with Nebr Health Human Services for Child Support Enforcement be added as an emergency item to the agenda. This agreement was due 8/18 to the Dept of Health and Human Services, and 2. Add the Local Recommendation Form for Special Designated Liquor License for a fund raising event at Ft Atkinson on 9/10 from Sandy Kucera, Too Far North. Motion Dethlefs second Frahm to add 2 emergency items to the agenda. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Motion Kramer second Anderson to strike the Kennard SE Project, CR32, October bid letting from the agenda for August 22, 2017 as the 8/8 motion was to table until Board has a better understanding of what jail costs are going to be. Board discussed information received in an email from Phil Lorenzen, DA Davidson Co which reviewed the funding for the Jail/Law Enforcement Project and the funding of Road Projects CR4 and Kennard SE CR32. Vote- Aye: Dethlefs, Kramer, Frahm, and Anderson. Nay: Lorenzen, Andreasen and Kruger. Motion carried. Motion Andreasen second Frahm to approve the agenda with the Kennard SE Project removed and 2 emergency items added. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Finance Chairman Kruger gave a recap of the Finance Committee meeting on 8/18. Budget discussion started off with Sheriff Mike Robinson speaking of his proposed budget, which includes costs for hiring 2 additional deputies. Many Sheriff Office employees were present and several members of the public. Motion Anderson second Andreasen to approve the Sheriff's budget as presented. Board discussed hiring additional deputies. Those speaking in favor of hiring 2 additional deputies were Brenda Orr, Ted Gillespie, Mike Anderson, Shane Thallas, Kevin Kermeen and Capt. Shawn Thallas. Kruger called for the question. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Vote to call for the question carried. The vote on the motion was- Vote- Aye: Dethlefs, Kramer, Frahm, Andreasen and Anderson. Nay: Lorenzen and Kruger. Motion carried.

VanderSchaaf discussed line items he reduced in his budget and had a hand out for the Board. Motion Anderson second Frahm to approve the County Attorney's budget as presented. Vote- Aye: Dethlefs, Kramer, Frahm, Andreasen and Anderson. Nay: Lorenzen and Kruger. Motion carried. Mike Smith went over the Weed Budget. Motion Kruger second Anderson to approve the Weed Dept budget as presented. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. Kruger went over the General Fund Miscellaneous budget. Motion Kruger second Anderson to approve the General Fund Misc. budget. Vote- Aye: Dethlefs, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: Kramer. Motion carried. Kruger asked if anyone had questions on any other budgets, hearing none, Kruger motioned, seconded by Andreasen, to approve the rest of the General Fund preliminary budgets: Co Board, Co Clerk, Treasurer, Register of Deeds, Assessor, Election, Planning Commission, Bldg Inspector, Data Processing, Clerk Dist Court, County Court, District Judge, Bldg & Grounds, Extension Office, Building, Communication Center, Child Support, County Jail, Surveyor, County Relief, Veteran's Service and State Institutions. Vote- Aye: Dethlefs, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: Kramer. Motion carried.

Kruger discussed various aspects of the County's revenue budget pages. Kruger and Dethlefs discussed Resolution 2017-13, to allow a 1% increase to the budget limit. Motion Kruger second Andreasen to adopt Resolution 2017-13. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

RESOLUTION 2017 – 13

Clerk discussed the preliminary requests from the political subdivisions subject to county levy authority. Motion Kruger second Dethlefs to authorize Chairman to sign letters to entities approving preliminary requests by Sept 1. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

At 2:30 PM, motion Frahm second Dethlefs to recess Board of Supervisor's meeting until after the Board of Equalization meeting. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. At 3:05 PM Board reconvened as Board of Supervisors.

It was moved by Frahm and seconded by Kruger that the rules be suspended and that the minutes of the Aug 8, 2017, meeting be approved and that minutes will not be read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. There was no correspondence.

Hwy Supt. Bill Hansel gave an update on road projects. Shane Swope, Engineer with Schemmer Associates, gave an overview of the Change Order #1 for CR 4 project. Swope said due to a change in the existing conditions (no base course under existing pavement) he increased the number of granular subdrains to provide improved drainage. Board discussed the information. Mike Anderson spoke. Motion Kruger second Dethlefs to approve Change Order #1 for \$47,310. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Phil Lorenzen, DA Davidson, distributed information regarding an update of County financing for the Jail/Law Enforcement Project, Co Road 4 and future CR32 improvements. Phil discussed the different statutes governing the authority for Jail bonds and the authority for Rural Road Improvement District bonds with the Board. Phil went over other pertinent information, including the County's levy and answered questions. Phil also said the Board could adopt a reimbursement resolution to show intent as to the jail project. Board discussed the information, no action was taken on the reimbursement resolution. Mike Anderson, Hansel and VanderSchaaf spoke.

Jessica Kolterman, Lincoln Premium Poultry and Walt Shafer, Project Manager, introduced themselves and discussed the Lincoln Premium Poultry/Costco Project in Dodge County. Board discussed the information.

Ryan Sullivan, Planning & Zoning Admin, had the following Public Hearings:

1. Lot Split: David Ruwe requests approval for Lot Split in the A-1 zone. Legal: Section 22 Township 19 Range 10E Location: County Road P17, Blair. Chairman opened a public hearing. Sullivan discussed the CUP. Chairman closed public hearing. Motion Kruger second Andreasen to concur with Planning Commission to approve Lot Split as presented. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

2. Rezone: David Ruwe requests approval of rezone of Lot Split to A-LSR. Legal: Sec22-T19-R10. Location: Co Rd P17, Blair Chairman opened a public hearing. Sullivan discussed the Rezone. Chairman closed public hearing. Motion Anderson second Kruger to concur with Planning Commission to approve Rezone as presented. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

3. Conditional Use Permit: Ross Ridenoure requests CUP for wedding venue in the A-1 zone. Legal: Tax Lot 14, Section 31 Township 19 Range 11E. Location: 16512 Co Road 18, Blair. Chairman opened a public hearing. Sullivan discussed the CUP and Planning Board action that recommended denying the CUP. Those speaking in favor of allowing the CUP were Frank Wilkins, Daniele Ridenour and Kevin Kermeen. Co Atty discussed the County's liability. Chairman closed public hearing.

Motion Kruger second Anderson to concur with Planning Commission to deny CUP as presented. Vote- Aye: Lorenzen and Kruger. Nay: Dethlefs, Kramer, Frahm, Andreasen and Anderson. Nays have it, motion did not carry. Motion Kramer second Anderson to refer this back to Planning Commission to look for resolutions for the remaining concerns and discuss modifications to the comprehensive plan that would modify land use to be more inclusive. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen and Anderson. Abstain: Kruger. Nay: None. Motion carried.

4. Amendment to Subdivision Regulations: Planning Office proposes amendment to subdivision regulations to allow for one lot subdivision. Chairman opened a public hearing. Sullivan discussed the Amendment. Kevin Kermeen spoke in favor of the amendment. Chairman closed public hearing. Motion Anderson second Andreasen to concur with Planning Commission to approve the amendment to subdivision regulations as presented. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Dethlefs had sent the Board copies of the Wash Co Sheriff's Office FOP Lodge 36 2017-2018 Labor Contract. The FOP has approved this and the Personnel Committee's recommendation is to approve the contract. Motion Kruger second Kramer to concur with Committee's recommendation to ratify FOP Lodge 36 2017-2018 Labor Contract and authorize Chairman to sign contract. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Clerk had Washington County Office Inventories for the Board's approval. Motion Kramer second Kruger to receive County Office Inventories and place on file. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Jesse Gonzalez, Building/Grds, discussed 3 informal bids received to purchase cameras for Law Enforcement bldg: Watchdog Electronics-\$6,039.86; Audio Video Specialist- \$6,884.24; Miller Electric- \$13,967. Motion Kruger second Kramer to concur with Bldg & Grds Committee to approve purchasing cameras for LE bldg for \$6,039.86 from Watchdog Electronics. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Board received 2 applications for Special Designated Liquor Licenses for a wedding reception and a fund raiser. Motion Kramer second Dethlefs to authorize Chairman to sign the Special Designated License Local Recommendation Forms for Heidi Wehmeyer, One Horse Saloon, for Wash Co Fairgrounds-Wedding Reception on 10/14 and Sandy Kucera, Too Far North, for Ft Atkinson State Park-Fundraiser on 9/10. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Kruger discussed transferring money, as per budget, to the Road Fund from the General Fund. Motion Kramer second Kruger to authorize Chairman to sign transfer of levied money in the amount of \$1,000,000 from General to Road Fund. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Lisa Kramer discussed the savings in changing the monthly Right Tech Computer Solutions service agreement to a flat rate per computer pricing. Motion Dethlefs second Frahm to approve service agreement amendment. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Board discussed the Co Atty's annual agreement for Child Support Enforcement. Motion Dethlefs second Kramer to authorize Chairman to sign the Subgrant Agreement with Nebr. Dept. Health Human Services for Child Support Enforcement services. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Committee Reports- Kramer said Region 6 will be asking Board to approve an amended interlocal agreement. There were no comments from public.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Andreasen that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.
