The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:00 p.m. on Tuesday, Oct. 24, 2017 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Carl Lorenzen declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present were Board members Steve Dethlefs, Bob Frahm, Lisa Kramer, Carl Lorenzen, Andy Andreasen, Jay Anderson and Steven Kruger. Also present were Deputy County Clerk Carol Kuhr and County Attorney Scott VanderSchaaf. There was no Board of Equalization.

Motion by Dethlefs and second by Andreasen to approve agenda for October 24, 2017. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. Motion by Kruger and second by Dethlefs that the rules be suspended and that the minutes of the Oct 10, 2017 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

The following correspondence has been received: Jail Standards Inspection Report and audit from the Northeast Nebraska Juvenile Services jail. Motion by Kruger and second by Frahm that the correspondence be received and placed on file. Vote-Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

County Highway Superintendent, Bill Hansel proposed sending a copy of the statute regarding mowing of roadsides and trimming of trees along County roads in the tax statements being sent out by the Treasurer's office. The Treasurer's office was aware of the plan and the Road Department would pay any additional postage required and list the Road Department phone number. County Road 4 is now open with final walk through in November. A traffic count on County Road P32 was discussed.

Kipp Kissinger, UNICO representative presented the County Insurance Committee recommendation for 2018 Health Insurance proposal and reviewed them as to changes for co-pays, and the deductibles mandated by ACA. He stated that Aetna, Blue Cross and NACO Pool Blue Cross had declined to bid. A bid from UMR for partially self-funding was received but not competitive. Motion by Andreasen and second by Frahm to approve UHC insurance proposed plan changes as recommended by Committee for the upcoming year to Option 19-PPO and Option 12-HSA. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. Motion by Andreasen and second by Dethlefs to approve the recommendation of the committee to make no change to the HSA contribution by the County of 2000/4000. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion of the commendation of the

Ryan Sullivan, Planning & Zoning Admin, had the following Public Hearings:

1. Conditional Use Permit: Salem Lutheran Church/representative Tom Moen. CUP request for accessory building with no primary building in FV Lots 5-8 Blk 10 (11022 11th St, Fontanelle) Planning Commission approved CUP for 25 years with CUP surety bond waived. Chairman opened public hearing. Sullivan discussed the CUP. Tom Moen spoke and corrected the address to 11055 and Block 101. He stated the Church is going to present a petition to vacate the alley, which would solve the issue for a CUP. He handed out information showing that part of 11th Street had already been vacated. Hansel discussed the process for vacation of a street or alley for an unincorporated village. Chairman closed the public hearing. Motion by Anderson and second Andreasen to approve the CUP for accessory building with no primary residence in FV Lots 5-8 Blk 101 for 25 years with surety bond waived. Upon further discussion regarding vacation of the alley, the motion was amended by Anderson and seconded by Andreasen to approve the CUP for 1 year with surety bond waived. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

2. Lot Subdivision: Tim Alberico request for a one lot subdivision of land under Article 3, Section 3.08 of the Zoning Regulations of Tax Lot 135 in Section 28 Township 18 Range 12 (Gen location Co Rd 41 & Co Rd 28, Ft Calhoun). Planning Commission approved the request as presented. Chairman opened public hearing. Sullivan discussed the one-lot subdivision.

Chairman closed public hearing. Motion by Frahm and second by Andreasen to approve one-lot subdivision on TL 135 in Sec. 28-18-12 under Article 3 of the zoning regulations. Board discussed with Sullivan whether this action would prevent a further lot split on the remaining 50 acres. Tim Alberico spoke. VanderSchaaf spoke. Kramer requested to make a motion to table, that would supersede the motion on the floor. Chairman allowed request. It was moved by Kramer and seconded by Dethlefs to table the one-lot subdivision action on TL 135 in Sec. 28-28-12 until further information on zoning regulations could be obtained. Vote- Aye: Dethlefs, Kramer, Kruger, Lorenzen, Andreasen and Anderson. Nay: Frahm. Motion carried. **3.** Conditional Use Permit: Ross & Danielle Ridenour request CUP to operate wedding venue on Tax Lot 14 Section 13 Township 19 Range 11 (16512 CR18, Blair). Referred back to Planning Commission at 8-22-17 Supervisor's meeting. Chairman opened public hearing. Sullivan discussed the CUP. He stated the Planning Commission denied CUP based on agricultural nature of the area and use of the gravel road. Danielle Ridenour stated that the venue could be for 30-40 weddings a year and it had adequate provisions for septic, ADA compliance, and parking. Julie Frost spoke in opposition. Mike Anderson spoke in favor. Chairman closed public hearing. VanderSchaaf stated the CUP was needed as this is a commercial business. Board discussed impact on agricultural area designated in the Comprehensive Plan, and impact on Blair area economy. Motion by Kruger and second by Anderson to deny CUP to operate a wedding venue on TL 14 Sec 13-19-11 based on incompatibility with the area. Vote- Ave: Dethlefs, Kramer, Kruger, Lorenzen, Andreasen and Anderson. Nay: Frahm, Motion carried. 4. Washington County Proposed Zoning Regulation Text Amendment: Marc Golden requests an amendment of zoning regulations to conditionally permit warehouse and distribution in the A-1 zoning district. (regarding property for purchase: Tax Lot 67 & 68, Sec 30-T17-R13 -4509 CR P38, Omaha). Planning Commission approved the proposed text amendment. Chairman opened public hearing. Sullivan discussed the amendment explaining this would affect all A-1 zoning, and that if approved a CUP would be needed for a warehouse. Edmond Talbot, Attorney for Golden, outlined the reason for the request was for Golden to purchase above property for a warehouse for his commercial carpet business. Marc Golden spoke about his business. James Michael Fitzgerald spoke in opposition. Bud Andersen, current property owner, spoke in favor. Chairman closed public hearing. Motion by Dethlefs and second by Kramer to accept the Planning Commission recommendation and approve amendment to zoning regulations to conditionally permit warehouse and distribution in the A-1 zoning district. Vote-Aye: Dethlefs, Kruger, Lorenzen, Andreasen and Anderson, Nav: Kramer, Frahm. Motion carried. 5. Conditional Use Permit Modification: Steve Lupardus requests a modification of CUP to add 50 RV sites for Cottonwood Cove Marina & RV Resort to include Tax Lot 27 Sec 30-T19-R12 (10270 Riverside Lane, Blair). Planning Commission approved CUP modification. Chairman opened public hearing. Sullivan discussed the CUP and added that it was subject to

floodplain regulations. Steve Lupardus spoke and handed out a map. Chairman closed public hearing. Motion by Anderson and second by Andreasen to approve CUP modification to include TL 27 Sec 30-19-12 as presented. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Ann Giebler, from LegalShield/ID Shield gave a presentation of a voluntary benefit plan for County Employees providing legal services and/or identity theft protection services. Board discussed information and requested an endorsement from NACO before approving the plan for County employees.

Sheriff Mike Robinson discussed the financing bids for purchases of 2 Chevrolet Tahoes and 1 Dodge Charger and equipment for 1 donated Chevrolet Tahoe. Board reviewed financing bids from Washington County Bank-4 year term with 2.83% interest rate; Two Rivers Bank-4 year term with 2.55% interest rate; US Bank-4 year term with 2.81 interest rate. Motion by Dethlefs and second by Anderson to approve the Sheriff's recommendation of financing for new vehicles by Two Rivers Bank as presented. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Sheriff Robinson discussed that one of the K-9 handlers was leaving and currently no one in the department wanted to be a K-9 handler. He asked the Board to consider 3 options: offer the dog to the benefactor that donated the dog; offer the dog to Omaha Police Department for \$3,000; set up an in-kind trade with OPD-the dog for use of the driving training track for 2 years and firing range one time use. Board discussed options. Motion by Kruger and second by Frahm to allow Sheriff to decide best use for the K-9 dog with benefactor being advised. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

County Attorney, VanderSchaaf requested the Board to rescind by mutual agreement the 2017 Child Support contract entered into by Washington County and Patrick Runge, authorized attorney. VanderSchaaf stated that this action would be budget neutral as it had already been provided for in this years' budget and the new attorney had been hired. Board discussed the need for a signed agreement with Runge. Motion by Anderson and second by Kruger to rescind by mutual agreement the 2017 Child Support contract entered into by Washington County and Patrick Runge, on the condition that Board has a document with signed consent by Runge to be signed by Chairman. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Committee reports: VanderSchaaf requested a meeting of the Finance Committee. Anderson reported on the Jail Committee meeting with Prohaska. Information handouts were given for a preliminary project schedule; preliminary estimate of project cost; and NRS 13-2901-construction management at risk. Anderson stated that the committee recommends having the County Surveyor complete a survey of the projected area before snowfall; committee meeting with the city and Prohaska regarding needed easements and permits, and developing an RFP for the construction manager at risk to have it approved at the next County Board meeting. Board discussed information presented. Glen Uffelmann, Mike Anderson and John Orr spoke.

Mike Anderson gave public comment.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Frahm that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.
