The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:05 p.m. on Tuesday, December 12, 2017 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Lorenzen declared the meeting was in session and that the meeting is being recorded. Lorenzen made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Carl Lorenzen, County Board Members, Steve Dethlefs, Lisa Kramer, Bob Frahm, Andy Andreasen, Steven Kruger and Jay Anderson. Also present, County Clerk Merry Truhlsen, Co Atty Scott VanderSchaaf and Sheriff Mike Robinson.

Motion Kruger second Dethlefs to remove the item for the One Horse Saloon Special Designated License for a reception at the Fairgrounds from today's agenda. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. VanderSchaaf said he had no problems with any agenda items. Kruger made a motion to not approve the agenda based on a Nov 14 vote on the plans for the Jail Project. There was no second, motion was not considered. Motion Kramer second Andreasen to approve the agenda. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen and Anderson. Nay: Kruger. Motion carried. It was moved by Frahm and seconded by Dethlefs that the rules be suspended and that the minutes of the November 28, 2017 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

It was moved by Andreasen and seconded by Frahm that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$275; Reg of Deeds \$33,022; Co Court \$17,640; Co Plan Dept \$15,749; Clk Dist Crt \$2,374; Sheriff \$1,847; and Road Dept \$57,449; Nov Treas Statement- Collections \$1,018,923; Disbursements \$2,176,828; Inheritance Tax \$548,043, Ending balance \$8,198,466. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. The following correspondence has been received: recommitment dividend check from NIRMA for \$10,069. It was moved by Anderson and seconded by Andreasen that the correspondence be received and placed on file. Vote-Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Kruger gave an update on Road Dept items as Bill Hansel, Hwy Supt, was absent. Motion Kruger second Dethlefs to authorize Chairman to sign the annual State Certification of County Highway Superintendent. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Several elected officials were present as the Board had lengthy discussion on setting the elected officials' salaries for the new term starting in 2019. VanderSchaaf, Sheriff Robinson and Mike Andersen spoke. Board had received a recommendation from the Nebraska Association of County Officials. Motion Anderson second Frahm to have the Finance Committee give salary recommendations at the Dec 26 meeting. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Don Prochaska and Curt Field, Prochaska & Assoc, discussed the findings of the water drilling study done at Courthouse and said nothing out of the ordinary showed up.

Mike Smith, Weed Supt, had submitted year end reports for the Board's review. Motion Kruger second Frahm to authorize Chairman to sign the Weed Dept reports. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Board had lengthy discussion regarding the financing and the design concept for the Wash Co Jail Project. Phil Lorenzen, DA Davidson, Don Prochaska, Sheriff Robinson, Mike Andersen, John Orr and Curt Field spoke. Motion by Kruger second by Dethlefs to use a voted bond issue to cover cost of project and put this on the May Primary ballot. The motion was discussed. Dethlefs rescinded his second, so without a second the motion was not considered. Board had more discussion. Motion Andreasen second Anderson to put the bond issue on the May Primary for the latest design on the north side of the Courthouse. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen and Anderson. Nay: Kruger. Motion carried.

Board next discussed a reimbursement resolution for the Jail Project costs. Motion Anderson second Frahm to authorize drafting a reimbursement resolution for hard and soft construction costs. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Board discussed the Construction Manager at Risk (CMAR) resolution. Motion Anderson second Dethlefs to adopt Resolution 2017-23 approving the use of a Construction Manager at Risk for the Jail Project. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen and Anderson. Nay: Kruger. Motion carried.
