The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:00 p.m. on Tuesday, Dec. 26, 2017 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Lorenzen declared the meeting was in session and that the meeting is being recorded. Lorenzen made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Carl Lorenzen, County Board Members, Steve Dethlefs, Lisa Kramer, Bob Frahm, Andy Andreasen, Steven Kruger and Jay Anderson. Also present, County Clerk Merry Truhlsen, and Co Atty Scott VanderSchaaf. There was no Board of Equalization.

Comments from public: Mike Andersen and John Orr spoke.

Motion Kruger second Dethlefs to approve agenda for December 26, 2017. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen and Kruger. Nay: Anderson. Motion carried. It was moved by Kruger and seconded by Dethlefs that the rules be suspended and that the minutes of the Dec 12, 2017 meeting be approved but not read at this meeting for the reason that all Board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. There was no correspondence.

Hwy Supt. Bill Hansel gave an update on road projects. At 3:15 the Board held a Public Hearing for the abandonment/vacation of an alley located between FV Lots 1-4 & Lots 5-8 Blk 101 Fontanelle, NE. Chairman opened a public hearing. There were no public comments. Chairman closed the public hearing. Motion Anderson second Andreasen to adopt Resolution 2017-22 and waive the reading of the resolution. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

RESOLUTION NO. 2017-22

BE IT RESOLVED BY THE WASHINGTON COUNTY BOARD OF SUPERVISORS WASHINGTON COUNTY, NEBRASKA:

WHEREAS, a report, as required in Neb. Rev Stat. 39-1722, has been received from the Washington County Highway Superintendent recommending the vacation or abandonment of a portion of alley located in the Village of Fontanelle, NE in Washington County, Nebraska and particularly described below:

That an alley that is approximately 33' wide X 150' long located between: FV Lots 1-4 Blk. 101 Fontanelle, NE (Parsonage) and FV Lots 5-8 Blk. 101 Fontanelle, NE (formally known as the Claasen property). These two properties are owned by Salem Lutheran Church, Fontanelle, NE.

WHEREAS, the Washington County Board of Supervisors held a Public Hearing in regard to the vacation or abandonment of a portion of an alley located in the Unincorporated Village of Fontanelle, NE in Washington County, Nebraska, as mentioned in above description, said hearing being held on Tuesday December 26, at 3:15 p.m. After the public hearing, the County Board of Supervisors deemed it to be in the public good that this portion of road right-of-way should be vacated and abandoned.

BE IT FURTHER RESOLVED THAT, the Washington County Board of Supervisors, pursuant to Neb. Rev. Stat. 39-1722, does hereby vacate or abandon said portion of alley located in the Unincorporated Village of Fontanelle, NE, in Washington County, Nebraska, more particularly described above, and that ownership of said alley shall revert to owner being Salem Lutheran Church in Fontanelle, NE.

Hansel discussed purchasing a motor-grader in the next budget year and had obtained state bids from both John Deere-\$317,000 minus 2013 Caterpillar trade-in \$90,000=\$277,000 (would have to purchase snow plow etc) and Nebraska Machinery Company-\$299,500 minus 2013 Cat trade-in \$150,000 and keeping current wing and plow for a total of \$137,500. Kevin Petersen, NMC, discussed the bid and said the County would also receive a \$12,000 parts credit. Motion Kruger second Andreasen to accept the State bid of a 2018 Caterpillar 12M, AWD motorgrader for \$137,500, with the trade in of a 2013 Cat,

keeping the wing and plow off the trade-in. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Kruger said in previous Board action any discussion on County Road 32, Kennard SE Project (aka Ft Calhoun cutoff) was tabled until the Board had a better understanding of the cost of the jail. Kruger said since the Board voted to put a bond issue on the Primary ballot to cover the cost of the jail at the last meeting, he talked to the Co Atty about putting an agenda item on to see if that satisfied the discussion on jail costs and Co. Rd 32 could now be discussed. Board members, Hansel and John Orr spoke. No action was taken, the Kennard SE Project, CR 32 remains tabled.

Terra Uhing, Executive Director, handed out copies of the Three Rivers Health Dept. Annual Newsletter and discussed the year's activities and numbers. Board discussed the information and thanked Uhing for the update.

Robin Andreasen, Co Assessor's office, had contracts for an extension of Thompson Reuters software support contract for the CAMA System for Dec 2018 - Nov 2019 (payable Dec 2018) in the amount of Assessors-\$15,935; Treasurers-\$6,484. Motion Anderson second Kruger to approve extension of contract. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Ryan Sullivan, Planning & Zoning Administrator, held Public Hearings for: 1. One-Lot Subdivision: Curtis Wichman requests approval for a one-lot subdivision under Article 3, Section 3.08 of the Washington County Subdivision Regulations. Legal Description: Tax Lot 22 in Section 16 Township 19 Range 11 and Tax Lot 26 in Section 21 Township19 Range11. Location: State Hwy 75 and County Road P 10, Blair, NE. Chairman opened public hearing. Sullivan discussed the request saying, among other things, the adjacent properties were in different sections. Curtis Wichman spoke, Chairman closed public hearing. Motion Andreasen second Anderson to concur with the Planning Commission and approve the one-lot subdivision as presented. Vote-Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. 2. Rezone from A-1 to RS-2: Curtis Wichman requests rezone from A-1 (primary agriculture) to RS-2 (rural subdivision) under Article 4, Section 4.02 of the Washington County Subdivision Regulations. Legal Description: Tax Lot 22 in Section 16 Township 19 Range 11 and Tax Lot 26 in Section 21 Township19 Range11 Location: State Hwy 75 and County Road P 10, Blair, NE. Chairman opened public hearing. Sullivan discussed the request. Chairman closed public hearing. Motion Kruger second Andreasen to approve the rezone request from A-1 to RS-2 as presented. Vote- Ave: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. 3. Conditional Use Permit: Monte Christensen of Leisure Properties request to not revoke CUP for RV Park and Campground under Article 6, Section 6.03 of the Washington County Zoning Regulations. Legal Description: Tax Lot 11 and 17, Section 6 Township 17 Range 13E. Location: County Road 47 and County Road 32, Ft Calhoun, NE. Chairman opened public hearing. Sullivan discussed the request with the Board. Co Atty spoke. Chairman closed public hearing. Motion Anderson second Kruger to table any action on Leisure Properties until Monte Christensen can be present and answer the Board's questions. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. 4. Sullivan next discussed the need to appoint 2 members to the Washington County Planning Commission as Gary Lambrecht and Dale Albracht's three year terms had expired. Sullivan had letters from 5 applicants applying for the 2 positions: Gary Lambrecht, Dale Albracht, Douglas Wolfe, Jeff Quist and Richard Hansen. Board voted by ballot. Clerk and Sullivan counted the votes: Lambrecht-4; Albracht-1; Wolfe-5; Quist-1; Hansen-3. Motion Kruger second Andreasen to appoint Gary Lambrecht and Doug Wolfe to the Planning Commission for the 2018-2020 term. Vote-Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Tracy Behnken, Extension Educator, discussed the need to fill 2 positions, for Kari Loeske and Dane Petersen, on the 11 member Extension Board. Behnken had 2 names for the Board to consider: Matt Mathiesen and Scott Stangl. Motion Anderson second Andreasen to appoint Matt Mathiesen and Scott Stangl to the Extension Board for a 3 year term, 2018-2020. Vote-Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Several elected officials were present to hear the Finance Committee's recommendation for setting the salaries for the new 4 year term starting in 2019. The salary resolution will be adopted at the Jan 9th meeting. Currently, Washington County salaries are the lowest of the 11 comparable counties in the Nebraska Association of County Officials salary study. Dethlefs discussed his compensation worksheet with various salary tables. Board discussed the information. Kruger said the Finance Committee also talked about freezing the Supervisors' salaries and doing 2 resolutions- one for Board members and one for the rest of the elected officials. Co Atty VanderSchaaf and Mike Andersen spoke. Motion Anderson second Frahm to accept the Table 2 salary chart which does 6% raises all 4 years, and do one salary resolution for elected officials, which includes the Supervisor's salaries. Vote- Aye: Dethlefs, Frahm, Andreasen and Anderson. Nay: Kramer, Lorenzen and Kruger. Motion carried.

Anderson said the Jail Committee met and discussed the need to have an evaluation committee in place to review the Construction Manager at Risk applicants. The evaluation committee will be comprised of a Jail Committee County Board member, stakeholders- Co Sheriff, Co Atty and Jailor/or Chief Deputy and outside member from Citizen's Advisory Committee.

Board and Co Atty discussed the committee. Motion Dethlefs second Frahm to empower the Jail Committee to formulate the selection of CMAR evaluation committee. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen and Anderson. Nay: Kruger. Motion carried.

Clerk had received the information the Board requested for the One Horse Saloon Special Designated License. Motion Kramer second Dethlefs to authorize Chairman to sign the SDL Local Recommendation Form for a reception at the Washington County Fairgrounds on Feb 24, 2018. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried.

Motion Kramer second Frahm to go into a closed session at 4:47 PM in order to protect the public interest with respect to attorney/client privilege discussion regarding contract negotiations. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. Those present were 7 Board members, the County Attorney, Deputy County Attorney Justin Hall and Sheriff Robinson. Chairman said the closed session was to protect the public interest with respect to attorney/client privilege discussion regarding contract negotiations. Motion Anderson second Kruger to come out of closed session at 5:12 PM. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. Chairman restated that the closed session was to protect the public interest with respect to attorney/client privilege discussion regarding contract negotiations. No action was taken.

Motion Kruger second Kramer to go into a closed session at 5:13 PM to discuss attorney client privileged information regarding potential litigation involving Washington County. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. Those present were 7 Board members, County Attorney and Deputy County Attorney Justin Hall. Chairman said the closed session was to discuss attorney client privileged information regarding potential litigation involving Washington County. Motion Kruger second Anderson to come out of closed session at 5:19 PM. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. Chairman restated that the closed session was to discuss attorney client privileged information regarding potential litigation involving Washington County. No action was taken.

Brief committee reports were given. There were no comments from the public.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Kramer that the following claims, with the exception of the claim to Andy's Mow Town, be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Andreasen, Anderson and Kruger. Nay: None. Motion carried. Motion Kruger second Dethlefs to approve payment of the claim to Andy's Mow Town for \$3,289.15. Vote- Aye: Dethlefs, Kramer, Frahm, Lorenzen, Anderson and Kruger. Abstain: Andreasen. Nay: None. Motion carried.
