The Washington County Board of Supervisors of Washington County met in regular session at 3:00 PM on Tuesday, January 9, 2018 in the Supervisor's room at the Courthouse, Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgement of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

County Clerk, Merry Truhlsen, declared the reorganization meeting for 2018 was in session and that the meeting is being recorded. Clerk made note that the Open Meetings Law is posted on the door and the west wall. Present: County Board members Carl Lorenzen, Steve Dethlefs, Lisa Kramer, Bob Frahm, Andy Andreasen, Steven Kruger and Jay Anderson. Also present, County Clerk Merry Truhlsen, and Co Atty Scott VanderSchaaf.

Clerk requested nominations for Chairman. Kruger nominated Lorenzen. Anderson nominated Dethlefs. Motion Frahm second Kramer that nominations cease. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. Clerk counted the ballots then announced Dethlefs is Chairman having received 5 votes, Lorenzen received 2 votes. Clerk requested nominations for Vice-Chairman. Anderson nominated Frahm. Kruger nominated Lorenzen. Motion Kramer second Andreasen that nominations cease. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. Clerk counted the ballots then announced Frahm is Vice-Chairman having received 5 votes, Lorenzen received 5 votes, Lorenzen and Anderson. Nay: None. Motion carried. Clerk counted the ballots then announced Frahm is Vice-Chairman having received 5 votes, Lorenzen received 2 votes. Chairman Dethlefs presided over the meeting.

Motion Anderson second Kruger to approve agenda for January 9, 2018. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. It was moved by Kruger and seconded by Kramer that Washington County Bank, Two Rivers Bank and the Nebraska Public Agency Investment Trust (NPAIT) be designated as depositories for County Funds in 2017. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. It was moved by Anderson and seconded by Lorenzen to authorize County Treasurer, Marj Hoier, to invest County Funds in any of the designated depositories. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

It was moved by Kramer and seconded by Kruger that the rules be suspended and that the minutes of the Dec 26, 2017 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. Motion Kruger second Andreasen to approve monthly fee reports: Co Clerk \$352, Reg of Deeds \$30,255, Co Court \$17,450, Co Plan Dept \$14,381, Clk Dist Crt \$2241, Co Sheriff \$1,906 and Road Dept \$97,361. Treasurer's Dec. statement: Collections 1,913,380; Disbursements 1,389,983; Inheritance Tax 598,564 Ending balance \$8,721,863. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. The following correspondence had been received: Emergency Management award nominations are being accepted. It was moved by Kruger and second by Frahm that correspondence be received and placed on file. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Motion Kramer second Andreasen to recess from the Board of Supervisor's meeting at 3:12 PM to go into Board of Equalization. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried. At 3:20 the Board reconvened as Board of Supervisors.

Hwy Supt Bill Hansel, gave a brief Road Dept update and set the One and Six Year Road Plan Hearing for February 13 at 6:00 PM. Hansel next discussed accepting bids for the Blair North bridge C89 (358) and the Washington NE bridge C89 (584). Christopher Lane, Speece Lewis Engineers, read through the three bids received. Totals for Bridge Projects C89(358) and C89(584) are: Dixon Construction Company \$2,098,376.20; Simon Contractors \$2,372,000; Herbst Construction \$2,142,505.30. Hansel asked for time to look the bids over and verify figures, then will return with a recommendation. Lane and Hansel returned at 4:20 PM and recommended accepting the Dixon Construction bid. Motion Kruger second Andreasen to accept the Dixon Construction bid on both bridges for \$2,098,376.20. Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

Atty Gregory Dietrich, Kutak Rock LLP, discussed the release documents regarding the Industrial Revenue Bonds, issued in 2000, being paid off by NatureWorks. Co Atty discussed the documents the Board had received. Motion Lorenzen second

Kramer to dispense with reading the resolution, adopt Resolution 2018-2 and authorize Chairman to sign Bill of Sale and Quit Claim Deed. Vote- Aye: Dethlefs, Kramer, Frahm, Kruger, Lorenzen, Andreasen and Anderson. Nay: None. Motion carried.

COUNTY OF WASHINGTON, STATE OF NEBRASKA RESOLUTION NO. 2018-2 RESOLUTION RELATING TO PREPAYMENT OF AMOUNTS UNDER LEASE AGREEMENT, SALE OF PROJECT SUBJECT TO SUCH LEASE AGREEMENT AND APPROVING RELEASE OF SECURITY UNDER SUCH LEASE AGREEMENT

WHEREAS, Washington County, Nebraska (the "County"), a political subdivision of the State of Nebraska, is authorized and empowered by the provisions of Sections 13-1101 to 13-1110, Reissue Revised Statutes of Nebraska, 1997, as amended (the "Act"), to finance a project, as that term is defined in the Act, and to issue its industrial development revenue bonds (the "Bonds") for the purpose of defraying the cost of acquisition, construction and equipping of a project; and

WHEREAS, the County previously issued its \$20,000,000 aggregate principal amount of Variable Rate Demand Industrial Development Revenue Bonds (Cargill Dow Polymers LLC Project) Series 2000 (the "Bonds"), the proceeds of which were used to finance all or a portion of the cost of acquiring, constructing and improving certain sewage and solid waste disposal facilities (collectively, the "Project") for Cargill Dow Polymers LLC, a Delaware limited liability corporation (currently known as Natureworks, LLC and herein referred to as the "Company") located at the Company's facility in Washington County near Blair, Nebraska; and

WHEREAS, the County and the Company entered into a Lease Agreement (the "Lease"), dated as of June 1, 2000, pursuant to which the County leased the Project to the Company in exchange for Lease Payments to be made by the Company under the Lease; and

WHEREAS, the County accepted the interests in the personal property and any real property constituting the Project, which were conveyed by the Company to the County at the time the Bonds were issued pursuant to a warranty deed and bill of sale, respectively; and

WHEREAS, in accordance with the Lease and the Trust Indenture, dated as of June 1, 2000 (the "Indenture"), between the County and Wells Fargo Bank, National Association, pursuant to which the Bonds were issued, the Company was granted the right to prepay all amounts required to be paid under the Lease, to terminate the Lease and to purchase the Project; and

WHEREAS, on January 8, 2018 the Company prepaid all amounts required to be paid under the Lease and caused the redemption of the Bonds on that date and, as required by the Lease, has tendered to the County the sum of \$100 as the purchase price for the Project; and

WHEREAS, the Company has requested that the County deliver to Company a Bill of Sale and Quit-Claim Deed for the Project in accordance with the requirements of the Lease; and

WHEREAS, there have been presented to this meeting the following documents, which the County proposes to execute and deliver to the Company in accordance with Section 6.09 of the Lease:

1. The form of Bill of Sale, dated as of January 9, 2017, transferring title to the portion of the Project representing personal property to the Company (the "Bill of Sale"); and

2. The form of Quit-Claim Deed, dated as of January 9, 2017, transferring title to any portion of the Project representing real property to the Company (the "Quit-Claim Deed").

WHEREAS, it appears that each of the instruments above referred to, which are now before each of the Members of the Board of Supervisors, is in appropriate form and is an appropriate instrument for the purposes intended;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF WASHINGTON COUNTY, NEBRASKA, AS FOLLOWS:

Section 1. That the form and content of the Bill of Sale be and the same hereby is in all respects authorized, approved and confirmed, and the Chairman and the County Clerk be and they hereby are authorized, empowered and directed to execute, attest to the execution of, seal with the official seal of the County and deliver the Bill of Sale, in substantially the form and content now before this meeting, but with such changes, modifications, additions or deletions therein as shall to them seem necessary, desirable or appropriate.

Section 2. That the form and content of the Quit-Claim Deed be and the same hereby is in all respects authorized, approved and confirmed, and the Chairman and the County Clerk be and they hereby are authorized, empowered and directed to execute, attest to the execution of, seal with the official seal of the County and deliver the Quit-Claim Deed, in substantially the form and content now before this meeting, but with such changes, modifications, additions or deletions therein as shall to them seem necessary, desirable or appropriate.

Section 3. That the provisions of this Resolution are hereby declared to be separable, and, if any section, phrase or provision shall for any reason be declared to be invalid, such declaration shall not affect the validity of the remainder of the sections, phrases or provisions.

Section 4. That all resolutions and parts thereof in conflict herewith are hereby repealed to the extent of such conflict. *Section* 5. That this Resolution shall become effective immediately upon its adoption.
