The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:05 p.m. on Tuesday, July 10, 2018 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Steve Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Carl Lorenzen, Lisa Kramer, Bob Frahm, Andy Andreasen and Steven Kruger. Absent: Jay Anderson. Also present, County Clerk Merry Truhlsen, and Deputy Co Atty Justin Hall.

Motion Frahm second Andreasen to approve agenda for July 10, 2018. Vote- Aye: Dethlefs, Kramer, Lorenzen, Frahm, Andreasen and Kruger. Nay: None. Motion carried. It was moved by Kruger and seconded by Andreasen that the rules be suspended and that the minutes of the June 26, 2018 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Dethlefs, Kramer, Lorenzen, Frahm, Andreasen and Kruger. Nay: None. Motion carried.

It was moved by Lorenzen and seconded by Kramer that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$366; Reg of Deeds \$35,582; Co Court \$25,399; Co Plan Dept \$10,321; Clk Dist Crt \$1,224; Sheriff \$1,750; and Road Dept \$191,042. Totals for the June Treas Statement were: Collections \$984,319; Disbursements \$3,542,806; Inheritance Tax \$1,051,703, Ending balance \$7,221,216. Clerk erroneously read totals for May. Vote-Aye: Dethlefs, Kramer, Lorenzen, Frahm, Andreasen and Kruger. Nay: None. Motion carried. There was no correspondence.

Bill Hansel, Hwy Supt, discussed a slope failure on County Road 30. Hansel had Speece Lewis Engineers assess the problem. The engineers suggested Terracon do borings to determine what is causing the issue. Once that is determined, engineers will design the fix. Cost is estimated at \$30,000 for the engineering and the borings. Motion Kruger second Kramer to sign contract with Speece Lewis that includes the cost of Terracon soil borings and engineering design on County Road 30. Vote-Aye: Dethlefs, Kramer, Lorenzen, Frahm, Andreasen and Kruger. Nay: None. Motion carried.

Hansel said it was time to order a new motor grader off the State bid. Board discussed the purchase. John Orr and Mike Andersen spoke. Motion Lorenzen second Kruger to authorize Road Supt order a Caterpillar 12M motor grader for \$139,000, with a trade-in of a Cat 140. Vote- Aye: Dethlefs, Kramer, Lorenzen, Frahm, Andreasen and Kruger. Nay: None. Motion carried.

Hansel gave the Board an update on road projects.

At 3:30 PM Chairman opened a public hearing for an application for Class I Liquor License, Delaney Bros. LLC, DBA Driftwood Inn. Jacob Delaney introduced himself and business partners Joshua Delany, Brett Highfill and Jeremiah Nolze. Jacob discussed plans for the business with the Board. There were no public comments. Chairman closed public hearing at 3:35 PM. Clerk read through Resolution 2018-10. Motion Lorenzen second Frahm to Adopt Resolution 2018-10. Vote- Aye: Dethlefs, Kramer, Lorenzen, Frahm, Andreasen and Kruger. Nay: None. Motion carried.

The MOU is a voluntary agreement to work to plan and implement the integration of the mobile radio system to provide for dual service redundancy. Motion Lorenzen second Frahm to authorize Chairman to sign MOU. Vote- Aye: Dethlefs, Kramer, Lorenzen, Frahm, Andreasen and Kruger. Nay: None. Motion carried.

Gary Lambrecht gave an update on plans and events for the 100th Annual Washington County Fair July 27 – Aug 1, 2018.

Bill Pook, Region 5/6 Emergency Management, gave an update on the grant application for an emergency manager for Washington County. Pook said he completed the grant on the County's behalf and will electronically submit this if the Board authorizes him to do so. Pook said the financial aspects quote a salary and benefits of \$67,500, equipment \$10,000 and operating expense at \$12,000, with a possible reimbursement of up to half of the allowable expenses. Board discussed the information. Motion Lorenzen second Andreasen to authorize Bill Pook to electronically submit the Emergency Management Grant for the County. Vote- Aye: Dethlefs, Kramer, Lorenzen, Frahm, Andreasen and Kruger. Nay: None. Motion carried.

Motion Kruger second Frahm to receive the Washington County Treasurer's Semi-Annual Statement and place on file. Vote-Aye: Dethlefs, Kramer, Lorenzen, Frahm, Andreasen and Kruger. Nay: None. Motion carried.

Chairman read through two Special Designated Licenses for Washington County Fairgrounds: 1. Sandy Kucera, Too Far North, Wine Tasting Event at Rybin Bldg, 7/31/2018 2. Arlington Youth Sports, Brad Soll, Barbeque Competition, Wash Co Fairgrounds, 8/10/18-5PM to 1AM and 8/11/18-8AM to 4PM. Motion Kruger second Frahm to authorize the Chairman sign both of the SDL Local Recommendation Forms. Vote- Aye: Kramer, Frahm, Andreasen, Anderson, Dethlefs and Kruger. Nay: None. Motion carried.

Kruger discussed the 2018-2019 County Budget and had a hand out showing the starting balances as compared to the previous year. Board members received a copy of the budget. Finance Committee will review the budgets then discuss the information with the Board. Mike Andersen spoke.
