July 24, 2018 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:05 p.m. on Tuesday, July 24, 2018 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Lisa Kramer, Bob Frahm, Andy Andreasen, Steven Kruger and Jay Anderson. Carl Lorenzen absent. Also present, County Clerk Merry Truhlsen, and Co Atty Scott VanderSchaaf.

Motion Kramer second Anderson to approve agenda for July 24, 2018. Vote- Aye: Kramer, Frahm, Lorenzen, Andreasen, Anderson, Dethlefs and Kruger. Nay: None. Motion carried. It was moved by Kruger and seconded by Andreasen that the rules be suspended and that the minutes of the July 10, 2018 meeting be approved but not read at this meeting for the reason that all Board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Kramer, Frahm, Lorenzen, Andreasen, Anderson, Dethlefs and Kruger. Nay: None. Motion carried. There was no correspondence.

Hwy Supt. Bill Hansel gave a brief update on road projects. Hansel said 4,700 tons of rock and 3,200 tons of gravel were hauled in the last month. Hansel next discussed the curve on County Road 30 that he recommended be closed for safety concerns, as did Speece Lewis Engineers. Hansel referred this to the State and is awaiting an opinion from the High Risk Rural Roads Dept. Board discussed the road and the poor visibility, due to crops, at the intersection of the road now being used. John O'Dell, Tom Vogt and Carl Shandell, who live in the area, spoke in favor of opening the curve back up. Vogt had photos of the area. Motion by Lorenzen to follow the recommendation of Road Supt and Speece Lewis Engineers to leave the curve on CR30 temporarily closed until we get an opinion from the State did not receive a second and wasn't considered. Motion Kruger second Andreasen to reopen curve until we get an opinion from the State then make a final decision. Vote- Aye: Kramer, Frahm, Andreasen, Anderson, Dethlefs and Kruger. Nay: Lorenzen. Motion carried.

Ryan Sullivan, Planning & Zoning Administrator has the following Public Hearings:

1. Conditional Use Permit: Jeff and Maria Bledsoe requests CUP for commercial dog kennel with advertising sign under Article 5, Section 5.03.03 of the Zoning Regulations for Tax Lot 13 in Section 18 Township 17 Range 12 (General location: CR 34 & CR P35, Blair) Planning Commission voted 7-0 to approve CUP request for 25 years, with the sign to be placed outside of the County right-of-way, the nonconforming building to remain unaltered and the business to remain the same. Sullivan went through the CUP. Chairman opened the public hearing. Jeff and Maria Bledsoe discussed the request. Mike Andersen spoke in favor of the request. Chairman closed public hearing. Motion Anderson second Frahm to concur with the Planning Commission to approve the CUP request for 25 years, with the sign to be placed outside of the County right-of-way, the nonconforming building to remain the same. Vote- Aye: Kramer, Frahm, Lorenzen, Andreasen, Anderson, Dethlefs and Kruger. Nay: None. Motion carried.

2. Rezone: Salem Lutheran Church requests rezone of property to enable lot merger under the Subdivision Regulations for Lots 5-8, Block 101, Fontanelle. (Gen location: 11th St & Nebraska St, Fontanelle) Plan Comm voted 7-0 to approve the rezone request. Sullivan went through the rezone request. Chairman opened the public hearing. Tom Moen, member of Salem Lutheran Church spoke. Chairman closed public hearing. Motion Kruger second Frahm to approve the rezone request. Vote- Aye: Kramer, Frahm, Lorenzen, Andreasen, Anderson, Dethlefs and Kruger. Nay: None. Motion carried.

3. Rezone: Salem Lutheran Church requests rezone of property to enable lot merger under the Subdivision Regulations for Lots 1-4, Block 101, Fontanelle. (Gen location: 11th St & Nebr St, Fontanelle) Plan Comm voted 7-0 to approve the rezone request. Sullivan went through the rezone request. Chairman opened the public hearing. Tom Moen, member of Salem Lutheran Church spoke. Chairman closed public hearing. Motion Anderson second Andreasen to approve the rezone request. Vote- Aye: Kramer, Frahm, Lorenzen, Andreasen, Anderson, Dethlefs and Kruger. Nay: None. Motion carried.

4. Conditional Use Permit: Mike McCarthy requests CUP to operate botanical garden on property under Article 5, Section 5.03.03 of the Zoning Regulations for Tax Lot 47 in Section 28 Township 17 Range 13 (Gen location: CR P51 & CR P40, Omaha). Plan Comm voted 7-0 to approve CUP request for botanical garden for a 25 year term. Sullivan went through the rezone request. Chairman opened the public hearing. Andy Callaway discussed the request. Chairman closed the public hearing. Motion Kruger second Lorenzen to approve the CUP request for 25 years. Vote- Aye: Kramer, Frahm, Lorenzen, Andreasen, Anderson, Dethlefs and Kruger. Nay: None. Motion carried.

Brian Mahlendorf, Weitz Construction, gave the Board information on the Washington County Justice Center regarding the process and summary of Bid Package #1, which includes various items, some of them being: site demolition, earthwork, structural concrete, basement waterproofing; and recommended Board approve Bid Package #1 for \$3,901,791. Joshua Sullivan, Weitz Construction, discussed the scope of Bid Package #1 and key dates. Kruger asked about a payment schedule. Board discussed the information. Motion Anderson second Kramer to approve Bid Package #1. Vote- Aye: Kramer, Frahm, Lorenzen, Andreasen, Anderson, Dethlefs and Kruger. Nay: None. Motion carried. Curt Field and Jim Classe, Prochaska & Associates discussed the project.

Co Atty VanderSchaaf discussed a proposal to change Kipp McKenize from a county employee to a contract employee. The Crime Commission, who reimburses McKenzie's expenses 100%, recommended the change to a contract employee. Motion Lorenzen second Frahm to authorize Chairman to sign the contract between Washington County and Kipp McKenzie, Washington County Juvenile Diversion Coordinator for July 1, 2018 to June 30, 2019. Vote- Aye: Kramer, Frahm, Lorenzen, Andreasen, Anderson, Dethlefs and Kruger. Nay: None. Motion carried.

Chairman read through the following Special Designated Liquor Licenses: 1.Nelson's Food Pride, Julie Johnson, Reception at Rybin Bldg, 8/11/2018 and 2.Nebraska Brewing Co, Kimberly Kavulak, Alpacas of the Heartland event @ 7016 CR39, Ft Calhoun, 8/24/2018. Motion Lorenzen second Andreasen to authorize Chairman sign the SDL Local Recommendation Forms for both events. Vote- Aye: Kramer, Frahm, Lorenzen, Andreasen, Anderson, Dethlefs and Kruger. Nay: None. Motion carried.

Finance Committee Chairman Kruger reviewed the proposed 2018-2019 county budgets that had been submitted. Phil Lorenzen, DA Davidson, had information for the Board regarding the financing and budgets for the Jail Construction and the Jail Bond Funds.

Comments from public- William Burdess spoke. Co Atty spoke. John Samson spoke.

Committee Reports- Kramer said the Tech Committee met and are recommending hiring an IT person in the next budget year.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Anderson that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Kramer, Frahm, Lorenzen, Andreasen, Anderson, Dethlefs and Kruger. Nay: None. Motion carried.
