September 25, 2018 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:05 p.m. on Tuesday, September 25, 2018 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Carl Lorenzen, Lisa Kramer, Bob Frahm, Andy Andreasen, Steven Kruger and Jay Anderson. Also present, Co Clerk Designee Barb Sullivan, and Deputy Co Atty Justin Hall.

Motion Frahm second by Anderson to approve agenda for September 25, 2018. Vote- Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried. Motion by Andreasen and seconded by Frahm that the rules be suspended and that the minutes of the September 11, 2018 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

The following correspondence has been received: Letters from Doris Karloff and Beth Fiegenschuh both asking for support in their running for re-election for NIRMA Board of Directors. Moved by Kramer and seconded by Lorenzen that the correspondence be received and placed on file. Vote- Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Bill Hansel, Hwy Supt, gave an update on road projects. Hansel said that matting is starting to be put down on the Blair bridge project, the Co Rd 40 bridge has the west pier cap poured and the Co Rd 34 reconstruction project still has issues with excess water. Hansel also stated that he spoke with Speece Lewis regarding slope failure on Co Rd 30.

Next Hansel discussed replacing a 2002 ¾ ton Chevy pickup. Hansel suggested to the Road Committee that the ¾ ton pickup be replaced with a ½ ton as he does not feel the need to have two ¾ ton pickups. Motion by Lorenzen and seconded by Kramer to concur with the Road Committee to authorize the purchase of a ½ ton gas crew cab pickup from State bid \$28,566. Vote-Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Hansel then discussed replacing mower and had received 3 quotes. Titan Machinery: \$13,500 with trade, Butler Ag: \$10,228.21 with trade, and Plains Equipment (John Deere): \$9,950 with trade. Motion by Kramer and seconded by Frahm to authorize Hwy Supt to replace mower with the John Deere for the amount of \$9,950. Vote- Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Lastly, Hansel discussed possible increase in Superintendent salary. Board received and discussed wage comparison study produced by Hansel. Motion by Anderson seconded by Kramer to deny salary increase. Vote- Aye: Lorenzen, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: Andreasen. Motion carried.

John Orr spoke. Mike Anderson spoke.

Jared Schleifer, Weitz Construction, provided an update on the Wash Co Justice Center construction and passed out a schedule outlining what is to be expected for the next 6 weeks.

Marj Hoier, Treasurer, discussed annual report by Co Treasurer of delinquent taxes not sold at annual tax sale. Hoier requested that the Board review report and direct her at next meeting to either have a Co Certificate against those properties or have the Co Attorney foreclose.

Board discussed and signed an Emergency Manager Grant Conflict of Interest Form.

Mike Robinson, Sheriff, discussed renewal of the 2 year Arlington Law Enforcement contract and Ft Calhoun Contract. Robinson said a 1.75% increase for both contracts were the only changes made. Motion by Kruger and seconded by Andreasen to renew the contracts with Arlington Law Enforcement and Ft Calhoun. Vote- Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Robinson, Sheriff, discussed renewing the Lease Agreement with the Village of Arlington for use of patrol vehicle. Motion by Anderson and seconded by Andreasen to approve the Lease Agreement with Arlington for use of patrol vehicle. Vote-Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Ryan Sullivan, Planning & Zoning Administrator:

- 1. Ron Hineline requests County Board to consider recommendation of Planning Commission on zoning designation of property. Sullivan read the Planning Commission's recommendation. John Orr spoke. Motion by Kruger and seconded by Lorenzen to have current zoning map show Tax Lot 76 be corrected back to Industrial-1. Vote- Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.
- 2. Planning Office requests Co Board to consider appointment of Planning Commission member for remainder of term of vacant seat. Sullivan reviewed staff packet given to Board members that included applications from Joe McBride, Ben Stangl, Richard Hansen, and Craig Linnenbrink. Mike Anderson spoke. Motion by Kruger and seconded by Lorenzen to vote for replacement by ballot. Vote- Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried. Ballot results: 3 votes for McBride, 2 votes for Stangl, 1 vote for Hansen and 1 vote for Linnenbrink. Motion by Andreasen and seconded by Kruger to appoint Joe McBride to Planning Commission. Vote- Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.
- **3.** Planning Office requests Co Board to consider resolution to adopt policy on selecting and appointing members to the Planning Commission. Sullivan read proposed policy to Board. Mike Anderson spoke. Sullivan also gave a floodplain update.

Personnel Committee: Dethlefs discussed addendum to contract between Washington County Sheriff's Office and FOP Lodge 36, the addendum covers wage schedule corrections. Motion by Kruger and seconded by Anderson to authorize Chairman to sign addendum with corrections. Vote- Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Chairman read through Special Designated License: Spirits by Beckman, Mike Beckman, Wahoo, NE, Wedding Reception, 10/20/18 at Washington Co. Fairgrounds. Motion by Lorenzen second by Kruger to authorize Chairman sign the SDL Local Recommendation Form. Vote- Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

There were no public comments.

Committee Reports- Personnel Committee discussed the Planning Commission appointment policy and also discussed adjustment of FOP contract and salary analysis. Jail Committee discussed Request for Proposal on furniture, storage, kitchen fixtures and laundry. Prochaska will bring a proposal forward. Finance Committee discussed raises that were given and retroactive back to July. Road Committee discussed a road owned by Cargill in which an easement was filed. The committee felt it was not in the county's best interest to incur any liability to maintain the road.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Lorenzen that the following claims be allowed with the exception of a claim from Co Attorney be changed from \$252 to \$126 and Clerk ordered to issue warrants on the various funds for the same. Vote-Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.
