October 23, 2018 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:00 p.m. on Tuesday, October 23, 2018 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Carl Lorenzen, Lisa Kramer, Bob Frahm, Andy Andreasen, Steven Kruger and Jay Anderson. Also present, Co Clerk Designee Barb Sullivan, and Co Attorney Scott VanderSchaaf.

Motion by Anderson and seconded by Frahm to approve agenda for October 23, 2018. Vote: Aye- Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay- None. Motion carried. It was moved by Kruger and seconded by Andreasen that the rules be suspended and that the minutes of the October 9, 2018 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote: Aye- Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay- None. Motion carried.

The following correspondence has been received: Letter to Sheriff's Office from Neb. Jail Standards Division that included Jail Standards Inspection Report for Washington County Detention Facility. Move by Kramer and seconded by Frahm that the correspondence be received and placed on file. Vote: Aye-Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay-None. Motion carried.

Bill Hansel, Hwy Supt, provided Road Dept update. Co Rd 34 is still under water and pumping equipment is still in use. Co Rd 40 bridge pilings should be done this week.

At 3:05 pm Hansel opened 3 bids for financing the 2018 Caterpillar Motor Grader: US Bank- 4.72% interest \$152,524.90 total, Two Rivers Bank- 4.6% interest \$152,447.02 total and Washington County Bank- 4.49% interest \$152,344.80 total. Motion by Kramer seconded by Kruger to accept bid from Washington County Bank with interest rate of 4.49% for the total of \$152,344.80. Vote: Aye- Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay- None. Motion carried.

Hansel discussed emergency situation involving Co Rd P32 road dam. Borings were done on the dam which found a lot of moisture. Terracon made recommendation to have drain tiles put in place, however road dam could fail before bidding process is done. VanderSchaaf also explained possible options to Board members. Motion by Anderson and seconded by Kruger to find an emergency situation on Co Rd P32 due to eminent dam failure. Vote: Aye-Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay-None. Motion carried.

Based on finding an emergency situation on Co Rd P32 it was moved by Kruger and seconded by Andreasen to waive bidding requirements for project on Co Rd P32 as per Neb. Stat 23-3109 subsection 2. Vote: Aye-Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay-None. Motion carried.

Motion by Kramer and seconded by Frahm to table agenda item #5, approving hiring contractor to perform emergency repairs on Co Rd P32 road dam. Vote: Aye- Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay- None. Motion carried.

Hansel discussed a possible temporary fix for bank failure on Co Rd 30. A possible void was found under road when borings were done by Terracon. Hansel provided suggestions on how to fix the issue. Board suggested that a plan of action be discussed at next Road Committee meeting.

Jared Schleifer, Weitz Construction, provided an update on the Wash Co Justice Center construction and passed out a schedule outlining what is to be expected for the next 6 weeks.

- 1. Sheldon Norton requests CUP for accessory building on A-1 zoned property under Article 3, Section 3.15 of the Zoning Regulation for Tax Lot 62 in Section 29 Township 18 North-Range 12 East of the Sixth PM (General location: CR P37, Blair, NE). Sullivan went through CUP request. Planning Commission voted 7-0 to approve CUP request. Chairman opened public hearing. Applicant Norton spoke. Chairman closed public hearing. Motion by Kruger second by Andreasen to concur with Planning Commission and approve CUP request. Vote: Aye- Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay- None. Motion carried.
- 2. Sherri Jacoby requests CUP modification for seasonal business under Article 5, Section 5.03 of the Zoning Regulations for Tax Lot 33 in Section 33 Township 18 North-Range 12 East of the Sixth PM (General location: CR P39, Ft Calhoun, NE). Planning Commission voted 6-0-1 (1 abstention) to approve request for 90 consecutive days from 1 Sept to 30 Nov with review in two years. No parking on gravel road except for one open house per year. The boutique may not be connected to the residence. Sullivan went through CUP request. Chairman opened public hearing. Applicant Jacoby spoke. Glen Peterson spoke. John Orr spoke. Chairman closed public hearing. Scott VanderSchaaf spoke. Motion by Anderson second by Kruger to concur with Planning Commission and approve CUP request. Vote: Aye- Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay- None. Motion carried.
- 3. Jeff Dross requests CUP to operate commercial kennel under Article 5, Section 5.03 of the Zoning Regulations for Lot 7 in the Rolling Acres subdivision (General location: North Ridge Rd, Ft Calhoun, NE). Sullivan went through CUP request. Planning Commission voted 1-6 to motion to approve request for maximum of seven dogs allowed for a two year term. Motion denied. Chairman opened public hearing. Mike Anderson spoke. John Orr spoke. Scott VanderSchaaf spoke. Chairman closed public hearing. Motion by Kruger second by Anderson to concur with the Planning Commission and deny CUP request. Vote: Aye- Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay- None. Motion carried.
- 4. Recognize updated extra territorial jurisdiction map for Ft Calhoun. Approve encroachment in two locations. (not a public hearing). Sullivan explained the purpose of map. VanderSchaaf spoke and answered questions from Board members. Motion by Lorenzen second by Frahm to recognize the updated extra territorial jurisdiction map as presented by the Planning and Zoning Dept concerning the Ft Calhoun encroachment in two locations. Vote: Aye- Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay- None. Motion carried.

Sheriff Mike Robinson and Capt Phil Brazelton: Presenting a plan for possible group purchase of radios for various entities in the Washington County Public Safety Communications Agency. Robinson stated sometime after Jan 2019 the Douglas County system will no longer support Washington County's technology. Robinson met with several entities last week to discuss a group purchase of equipment and he explained to Board members proposed plan for said purchase. VanderSchaaf spoke and explained that there would be a Memorandum of Understanding with each agency. Brazelton stated that he was able to obtain money from Nebraska State Homeland Security Grant.
