The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:05 p.m. on Tuesday, December 11, 2018 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Vice Chairman Bob Frahm declared the meeting was in session and that the meeting is being recorded. Frahm made note that the Open Meetings Law is posted on the door and the west wall. Present: Vice Chairman, Bob Frahm, County Board Members, Carl Lorenzen, Lisa Kramer, Andy Andreasen, Steven Kruger and Jay Anderson. Absent: Chairman Steve Dethlefs. Also present, County Clerk Designee Barb Sullivan, and Co Atty Scott VanderSchaaf.

Motion Anderson second Andreasen to approve agenda for December 11, 2018. Vote- Aye: Lorenzen, Kramer, Frahm, Anderson, Andreasen, Kruger. Nay: None. Motion carried.

It was moved by Kramer and seconded by Andreasen that the rules be suspended and that the minutes of the November 27, 2018 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote-Lorenzen, Kramer, Frahm, Andreasen, Anderson. Abstain: Kruger. Nay: None. Motion carried.

It was moved by Kramer and seconded by Kruger that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$431; Reg of Deeds \$32,435; Co Court \$16,283; Co Plan Dept \$3,066; Clk Dist Crt \$1,817; Sheriff \$1,444; and Road Dept \$812; November Treas Statement- Collections \$465,519; Disbursements \$2,494,183; Inheritance Tax \$628,481 Ending balance \$19,967,540. Vote- Aye: Lorenzen, Kramer, Frahm, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Letter to Board from Nebraska State Historic Preservation Office announcing the George A. Marshall House is officially listed in the National Register of Historic Places. **3**. Lodging Tax Revenues for tax year 2017 totals were \$14,721.02 and Jan - Sept 2018 are currently at \$11,631.42. Motion Kramer second Anderson that the correspondence be received and placed on file. Vote- Aye: Lorenzen, Kramer, Frahm, Anderson, Andreasen, Kruger. Nay: None. Motion carried.

Bill Hansel, Hwy Supt: 1. Road Dept update: Co Rd 34 reconstruction is being de-watered and work continues as long as weather allows. Deck will be poured this week for bridge on Co Rd 40. Co Rd 32 is waiting for DNR to approve the fix after receiving sonar report. Co Rd 30 bank failure is waiting for Terracon to approve sample of material to see if it is suitable to help stabilize bank. Vogt Construction wants to start construction on box culvert on Co Rd 18 & 5.

County Board to appoint members to the Washington County Planning Commission for a 3 year term. Frahm discussed voting procedures and Co Attorney VanderSchaaf advised Board of voting options. Board agreed to have 2 separate votes, one for each open position, via secret ballot. The seven applicants were Mike Anderson, Chris Bilau, Holly Bonasera, Richard Hansen, Matt Mathiesen, Joe McBride, and Cynthia Timmermier. Position #1 (Matt Mathiesen seat) vote: 6 votes for Matt Mathiesen. Position #2 (Joe McBride temporary seat) vote: 1 vote for Joe McBride, 3 votes for Mike Anderson, 1 vote for Cynthia Timmermier, 1 vote for Chris Bilau. Board to vote for position #2 again as it needs a majority vote. Position #2 second vote: 4 votes for Mike Anderson, 1 vote for Cynthia Timmermier, 1 vote for Chris Bilau. Motion Kramer second Andreasen to affirm Matt Mathiesen and Mike Anderson as next term Planning Commission members. Vote- Aye: Lorenzen, Kramer, Frahm, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Phil Brazelton, Communications Captain: Amended/Restated Interlocal Agreement for Land Mobile Radio Sharing adding Sarpy County. Brazelton stated that with Sarpy Co joining Interlocal Agreement it should reduce ongoing costs to Washington Co but does not have hard figures at this time. VanderSchaaf stated that he looked at the Amended Agreement and had no issues with it. Motion Kramer second Lorenzen to approve Vice Chairman and Co Attorney to sign Amended Interlocal Agreement. Vote- Aye: Lorenzen, Kramer, Frahm, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

There were no public comments.

Committee Reports: Road committee discussed 1 & 6 road plans putting items on that board members thought were a priority for next year. Also discussed was the potential of needing dump truck and vehicle for Road Dept employees as well as regulations regarding Co employees taking work vehicles home and the insurance implications. Jail committee reviewed the status of construction. Anderson said dewatering is being moved to west side and soil fill will begin. Board members discussed possible implications of potential water seeping into jail in the future as well as complaints received from home owners about vibrations from construction equipment compacting soil. Technology committee continued to work on the job descriptions and duties for new IT person. Mike Anderson spoke. Kruger provided Board members with a comparison of County funds for Nov 2018 vs 2017 and stated the net difference is -\$2,746,664.

Claims were received and reviewed, following which it was moved by Kruger and second by Andreasen that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same.
