1. Request by Bill Rhea to Operate Borrow Pit on Property

A request to excavate soil under Article 7, Section 7.02 of the Zoning Regulations for Tax Lot 12 in the NW ¼ SE ¼ in Section 10 Township 18 North-Range 9 East of the Sixth P.M. (General Location: Co. Rd 7 and State Hwy 91, Fontanelle, NE).

Bill Rhea explained that he would be removing dirt from this site and moving to another site for a construction project in Fremont.

The Commission asked for a report from Lincoln Premium Poultry (LPP)

Walt Schaefer, COO of Lincoln Premium Poultry (LPP), gave a report for the Planning Commission. He explained the purpose of LPP was to promote and support the family farm and help them diversify. LPP has criteria the applicants must follow. The applicants must obtain a State Operating Permit. The nutrient management plan must be in place. LPP is there to help and support farmers.

Andy Scholting, Nutrient Advisors, gave a report to the Planning Commission. The purpose of Nutrient Advisors is to develop a nutrient management plan for each site and help them meet all NDEQ and EPA guidelines. Each site is completely encased, no outside waste storage or lagoons. They are not required to have a permit with the NDEQ. The NDEQ has visited all sites and have written letters to all applicants that no permit is required. LPP and Costco is requiring all growers to obtain a NDEQ permit anyway. All growers have voluntarily submitted a nutrient management plan. The Nebraska Siting Matrix (NSM) has been completed for each site. These sites are completely housed and under roof. A score of 70 is required to get a CUP. Most of these sites score over 100. The odor footprint tool was also provided by UNL. Scholting explained how the odor footprint was developed and what it means. Scholting also explained how much liter would be created by each barn, the nitrogen content and phosphoresce content and how much would be produced by these six sites.

He then answered questions from the Planning Commission regarding the process, the building, the shavings, the compost building, and the truck traffic.

A request for a Poultry Barn under Article 5, Section 5.03.03 of the Zoning Regulations for the SW ¼ NE ¼, W ½ SE ¼ in Section 28 Township 18 North-Range 9 East of the Sixth P.M. (General Location: Co. Rd 28 and Co. Rd 3, Arlington, NE).

Chairman Lambrecht opened the public hearing.

Sullivan presented comments provided to the Planning Office prior to the opening of the public hearing which were asked to be part of the public hearing. Reasons cited for opposition were: property value decreases, will ruin the view, wrong location, does not fit with the Comprehensive Development Plan for the County, water and soil contamination, smell or odor, water usage, will stymie economic growth, disease outbreak, will spread pathogens to humans, air pollution, negative impact on roads, will ruin lives, opposed to any animal confinement site, inhumane practices, will bring in crime, too many residential sites in the immediate area, and they are industrial by nature.

Scott VanderSchaaf, County Attorney, explained how he advised Sullivan to categorize the emails received and report that to the Planning Commission. They are to be made part of the public record but not read out loud. VanderSchaaf stated he would be there all night to answer questions.

Eric and Calli Soll presented information to the commission. They propose to have four poultry barns on their property. They are both long term residents of Washington County and wish to build a home on the site of the barns. The liter will be going to their fields.

Matt Johann, Chase Kratochvil, Tony Riecken, Nick Bell, Dusty Bell, Julie Hindmarsh, Jeff Burianek, Jim Wilkening, Amanda Barron, Jill Reel, Bob Lossi, Chris Start and Tracy Scalf spoke against the proposed operation.

Gene Soll and Kristin Hasalbrook spoke in favor of the operation.

Chairman Lambrecht closed the public hearing.
