The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:04 p.m. on Tuesday, February 26, 2019 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Jordan Rishel, Lisa Kramer, Bob Frahm, Andy Andreasen, Jay Anderson, and Steve Kruger. Also present, Co Sheriff Mike Robinson, and Co Attorney Scott VanderSchaaf.

Motion Kramer second Frahm to approve agenda for February 26, 2019. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Kramer and seconded by Rishel that the rules be suspended and that the minutes of the February 12, 2019 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Claims were received and reviewed, following which it was moved by Kruger and second by Frahm that the following claims at the end of these minutes be allowed, except for court appointed attorney fee claims that had not been verified by the Co Attorney, and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

It was moved Frahm and seconded by Andreasen that the following correspondence be received and placed on file: **1**. Board of Directors meeting notice from MAPA. **2**. Letter from Neb DOT stating proposed improvements to US Hwy 75. **3**. Letter from Judge Sampson stating court appointed attorney fee rate will increase to \$95.00/ hour staring 7/1/19. Bill Hansel, Hwy Supt, said Road Dept did not spend much time on projects due to time spent on snow removal. Co Rd 32 (Calhoun cutoff) will be up for approval at the Relaxation of Standards meeting set for March 15 at 9:00.

At 3:10 pm, the Chairman opened a public hearing on the Washington County One & Six Year Road Improvement Plan. Hansel had handouts showing the various projects on the One Year Plan and Six Year Plan and went over different aspects. There was no public comment. Chairman closed public hearing. It was moved by Kramer and seconded by Anderson to accept ONE)1) & SIX (6) Year Highway Improvement Program by Resolution 2019-03. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

- (2) In order to qualify for said funds the County must, among other things, prepare an annual One (1) and Six (6) Year Program for highway improvements, conduct a local public hearing and submit the results to the Board of Public Roads Classification and Standards.

(3) The County of Washington, Nebraska does hereby adopt the 2019-2024 One (1) and Six (6) Year Program as proposed by the Washington County Highway Superintendent, with the following changes: ______
The foregoing Resolution having been read, Supervisor Anderson seconded the motion for its passage

and adoption and the roll being called on the passage of said Resolution, the following voted: ROLL CALL VOTE: YEA 7; NAY 0; Absent 0. Resolution adopted, signed and billed as adopted. WASHINGTON COUNTY BOARD OF SUPERVISORS Barbara Sullivan Steve Dethlefs Washington County Clerk Chairman

Hansel then discussed options that were reviewed with the Road Comm regarding dump truck bids that were received at last Board meeting. Several bids were received with various models, options, and prices. Hansel said after reviewing the options he recommends purchasing 2 Mack GR64R trucks from Northern in the amount of \$317,960 total after trade in. Motion Kruger second Frahm to concur with the Hyw Supt and award dump truck bids to Northern/Sander. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Next Hansel discussed with Board members approval of preliminary and final design for project C89 (427) Co Rd P16 West of Hwy 75. Packet from Speece Lewis was given to Board members detailing design and cost. Hansel stated that the project can take 2-3 yrs to get moving so it would be beneficial to get approval now. It was moved by Kramer and seconded by Andreasen to approve engineering in the amount of \$112,500 on Co Rd P16. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Lastly Hansel discussed approval for supplemental agreement for Co Rd P32 road dam. Hansel explained reason for supplemental agreement is to cover the expense that was incurred by Speece Lewis when DNR needed additional items to be completed. Cost is \$16,200 in additional to the original cost of \$42,750 which included the Terracon contract. Mike Anderson spoke. Motion Kruger second Kramer to approve the additional \$16,200 for the supplemental agreement for Co Rd P32. Vote-Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Comments from Public: Larry Voss, Township Board #7, commented on road maintenance in his area.

Jared Schleifer, Weitz Construction, gave a brief update to Justice Center project. Crews were able to work despite snow and wall forms are staring to be poured this week. Schleifer also answered questions from Board members about billing statements.

Board discussed with Schleifer the Asbestos Inspection bids for Jail and current courthouse buildings and having cost come out of the Building & Grounds Budget. Anderson said the Jail Comm discussed the added value of having the entire Courthouse inspected. Motion Anderson second Frahm to approve Asbestos Inspection bid for Courthouse for the total of \$7350 and have it come out of Building & Grounds budget. Vote-Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Anderson discussed Justice Center Builders Coverage and reviewed what is already covered thru Weitz and what was quoted by NIRMA. Kruger asked if there was any added value of having coverage with two different insurance policies and if there could be potential conflicts. Board decided stay with contract provided by Weitz. No action taken.

Board discussed remaining soft cost expenditures and how to proceed with assigning who will handle the RFP and acquisition of material. Weitz and Prochaska both provided price sheets that outlined soft cost expenditures. Anderson said that even though Prochaska is slightly less expensive they will still need to go thru Weitz for most of the work. Schleifer explained that if Weitz were to do the procurement then they would handle the bidding and solicitation and cost is covered under the GMP. Soft costs would include but are not limited to furniture, laundry, computers, and kitchen supplies. Kramer reminded Board members of sealed bid processes that the County must adhere to and if Weitz would have to follow the same procedures. Co Attorney VanderSchaaf suggested that the Board table the agenda item until Attorney's office can review process. Sheriff Robinson spoke. Motion Kruger second Kramer to table item until further review from Co Attorney. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.
