The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:04 p.m. on Tuesday, May 14, 2019 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Steve Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Jordan Rishel, Lisa Kramer, Bob Frahm, Andy Andreasen, Jay Anderson and Steven Kruger. Also present, Co Clk Barbara Sullivan, Co Sheriff Mike Robinson and Co Atty Scott VanderSchaaf.

Anderson asked to have "Public Comments" be moved up so Jail Update can be presented. Motion Kruger and second by Andreasen to approve agenda for May14, 2019. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nav: None. Motion carried.

It was moved by Andreasen and seconded by Rishel that the rules be suspended and that the minutes of the April 23, 2019 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Kruger stated reasons for holding Prochaska and Terracon claims from last meeting was due to the lack of details provided on invoices to which have since been rectified. Claims were received and reviewed, following which it was moved by Kruger and second by Frahm that the following claims at the end of these minutes be allowed and Clerk ordered to issue warrants on the various funds for the same. Moved Kruger and seconded Rishel that the correspondence be received and placed on file. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Public Comments: Jared Schleifer, Weitz Construction, gave a brief update to Justice Center project. Large generator is set to be installed 5/16 on east side of Courthouse and steel erections will start this week.

Bob Smith, Road Foreman, Road Dept update: Box on Co Rd 18 is complete and open. Bank on Co Rd 30, Rolling Acres, is still being worked on. Water is still an issue for Co Rd 34, east of Ft Calhoun, and the bridge on Co Rd 40.

3:15 Smith opened the following bid for rock and gravel: Johnson Trucking, \$15.40 per-ton road gravel. No rock bids or other gravel bids were received. Motion Kruger second Andreasen to accept bid from Johnson Trucking. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried. VanderSchaaf and Board members discussed concerns of whether the motion should be rescinded and then reject the bid as only 1 bid for gravel and not rock was not received. Motion Kramer second Anderson to recall the motion. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried. It was then moved by Kramer and seconded by Rishel to rescind the motion. Vote- Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion Kruger second Kramer to reject all bids. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Motion Kruger second Kramer to authorize Road Dept to repost notice in newspaper for rock and gravel. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

3:30 Smith opened the following bids for culverts: Midwest Sales & Service, B's Enterprise Inc and Metal Culverts. Prices varied depending on the diameter and gage of spiral pipe, riveted pipe and 24" wide band-welded flanges bolts & nuts. Motion Kruger second Andreasen to accept all bids and allow Road Dept to proceed. Vote- Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Kramer asked to have a letter from Region 6 stating the FY20 county match requirement for Wash Co is projected to be \$60,309 for fiscal year beginning 7/1/2019. Motion Kruger second Frahm to accept and place on file the additional correspondence. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

3:35 Phil Lorenzen, DA Davidson & Co, discussed the Bond Underwriting Engagement Letter and said the letter outlines the roles and services provided by DA Davidson as underwriter as well as fees and terms. Lorenzen provided a packet to the Board and gave a detailed summary of its contents that included, but not limited to, a maturity schedule for the Law Enforcement Center Bonds Series 2018 as well as tax levy report and a municipal market update. Lorenzen also stated the importance of determining in the near future what portion of the remaining \$8.5 million of the Bonds should be issued as setting the 2019-2020 budget is fast approaching. Motion Kruger second Anderson to authorize Chairman to sign Engagement Letter. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Brad Wrich discussed his request for a strip of land near his property to be designated as a county road. Colton Harper and Mike Anderson spoke. Board members and Co Atty VanderSchaaf discussed options. It was moved by Anderson and seconded by Andreasen to refer to Road Committee for further direction. Vote- Aye: Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: Rishel. Motion carried.

Steve Mencke, Assessor, discussed renewal contract with gWorks (WebGIS Subscription Renewal-Assessor Tab). Mencke stated that the renewal contract had been reviewed and approved by Co Atty VanderSchaaf. It was moved by Kruger and seconded by Kramer to renew a 3year contract with gWorks for the annual cost of \$5,040. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Mike Robinson, Sheriff, discussed financing for 2 patrol vehicles and passed out packet detailing costs. Total cost for vehicles including trade-ins and equipment is \$53,790.37. Bids were received from the following banks: Two Rivers Bank, 3.45% interest; Washington County Bank, 4.45% interest; US Bancorp, 4.45% interest (all terms being the same). Motion Kruger second Andreasen to approve financing through Two Rivers Bank. Vote- Aye: Lorenzen, Kramer, Frahm, Dethlefs, Andreasen, Anderson. Nay: None. Motion carried

Kramer stated that Board members and Co Attorney have received a copy of the contract with Turnkey Nerds for IT Services and have approved of the terms. It was moved by Kramer and seconded by Rishel to authorize Chairman to sign contract with Turnkey Nerds. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Arlington Youth Sports, Tractor Pull Fundraiser at Wash Co Fairgrounds, 6/8/19, 4 p.m. to 1 a.m. Motion Kruger second Rishel to authorize Chairman to sign SDL Local Recommendation Forms. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Committee Reports: Frahm stated that the Co Visitor's Promotion had asked for \$12,740 and was accepted as the funds were available in their account. Personnel Comm met and addressed some personnel counseling, evaluation and training. Jail Comm met and were able to find several cost saving areas.

At 4:41 p.m. it was moved by Andreasen and seconded by Rishel to go into closed session for the purpose of discussing attorney client privileged information regarding potential and/or imminent of litigation involving Washington County. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried. Those present were 7 Board members and Co Atty Scott VanderSchaaf. Chairman restated the closed session was for the purpose of discussing attorney client privileged information regarding potential and/or imminent of litigation involving Washington County. At 5:47 p.m. it was moved by Andreasen and seconded by Anderson to come out of closed session. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried. In open session it was moved by Kruger and seconded by Andreasen to authorize refund out of Inheritance Tax Fund for \$55,885.73 that was collected in error.
