The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:\_\_ p.m. on Tuesday, June 11, 2019 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Steve Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Jordan Rishel, Lisa Kramer, Bob Frahm, Andy Andreasen, Jay Anderson and Steven Kruger. Also present, Co Clk Barbara Sullivan, Co Sheriff Mike Robinson and Co Atty Scott VanderSchaaf.

Motion Kramer and second by Frahm to approve agenda for June 11, 2019. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried. It was moved by Anderson and seconded by Rishel that the rules be suspended and that the minutes of the May 28, 2019 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Claims were received and reviewed, following which it was moved by Kruger and second by Andreasen that the following claims at the end of these minutes be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote-Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Kruger and seconded by Andreasen that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$455; Reg of Deeds \$37,632; Co Court \$14,848; Co Plan Dept \$8,597; Clk Dist Crt \$2,204; Sheriff \$3,397; and Road Dept \$100,450; May Treas Statement- Collections \$1,375,180; Disbursements \$2,279,623; Inheritance Tax \$1,023,335 Ending balance \$21,472,747. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

The following correspondence has been received: **1**. Letter from Ritterbush & Piotrowski announcing Seth Christiansen, CPA, as firm Partner as Mark Preston has resigned. **2**. Notice of Public Meeting from SID #10 set for June 11. Motion Andreasen second Frahm that the correspondence be received and placed on file. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Kipp Kissinger, UNICO, Insurance broker for the County, discussed the annual mid-year review of claims with United Healthcare. Kissinger had information for the Board and touched on some high-level data points that dictate renewal prices.

Jared Schleifer, Weitz Construction, gave a brief update on Justice Center project.

Sheriff Mike Robinson: 1. Discussion of shortfall on end of year budget. Robinson stated that the Sheriff and Communication budgets will be short however there will be funds available from Corrections budget to transfer. Robinson said he will have deciding figures for transfer ready by next meeting. 2. Robinson announced that Arlington and Ft Calhoun Schools Districts have approved the hiring of a full-time School Resource Officer. A new candidate has already been interviewed by Superintendents and, if hired, will join current SRO Deputy Nicole Kruse.

**3:30** Patty Lyon, Chief Probation Officer for District 6, introduced Tim Privitera, Drug Court Coordinator, who gave an update on program and review of New Biennium Agreement. Lyon also stated that Probation will now be funding for Drug Technician position which currently the County had been responsible for, saving the county about \$55,000/ yr. Motion Kruger second Anderson, to authorize Chairman to sign New Biennium Agreement. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Rob Bellamy, Corrections Capt, discussed the potential of hiring a Food Service Provider for the Washington Co Justice Center. There is 1 full-time employee to prep food for the current 15 bed facility and with the new 120 bed facility it may be more

efficient and cost effective to contract with a Food Service Provider. Bellamy provided Board Members a handout that outlined cost of county staffing verses a contract scenario as well as other items of consideration.

Ryan Sullivan, Planning & Zoning, went through Resolution 2019-07; Upholding Zoning and Zoning Enforcement. Co Attorney VanderSchaaf also explained the intent behind the Resolution. Clerk read thru the Resolution. Motion Anderson second Andreasen to adopt Res 2019-07, Upholding Zoning and Zoning Enforcement. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson. Nay: Kruger. Motion carried.

## RESOLUTION FOR UPHOLDING ZONING AND ZONING ENFORCEMENT, WASHINGTON COUNTY, NEBRASKA

Adopted: 06-11-19, Res. #2019-07

A RESOLUTION PROVIDING FOR A DECLARATION BY THE COUNTY BOARD TO ACKNOWLEDGE ONGOING ABUSE OF ZONING REGULATIONS PERTAINING TO COMMERCIAL USES OF PROPERTY NOT ZONED FOR SUCH ACTIVITY.

This Resolution provides for public acknowledgement by the Washington County Board of Supervisors that a disregard and active denial of the adopted Zoning Regulations are becoming pervasive in nature. The continuation of this trend will all but guarantee persistent litigation for the county with the cost being absorbed by the residents and taxpayers.

Washington County would like existing and future residents to understand that unincorporated jurisdictions are zoned differently than incorporated jurisdictions, such as a city or village. The land use and planning for a county will differ greatly from that of a city or municipality. For reasons of infrastructure, provisions of services, agricultural preservation, and other measures, counties will not compete with cities for lot size, commercial and retail zoning, and extension of services. Annexation of land by cities is typically seen long before counties should consider expenditures of urban growth corridors and infrastructure expansion.

A county, by right, and specifically outlined in state statute, is permitted to adopt zoning and land use policy as well as to administer and enforce that policy. To argue the intent of the written text, and even the interpretation of the regulations may provide an avenue for an appeal or variance in some cases, but to simply disregard the zoning altogether and challenge the county to intervene in some way has become the common rejoinder, and it is the county's duty to uphold the appropriate governing regulations.

In the event that an individual is notified of a clear zoning violation, and chooses to ignore the standards for either obtaining the proper permits or in some cases the approval of the County Board of Supervisors, a sign notifying the public of the nature of the violations will be placed in the right of way adjacent to that property. Any attempt or action to remove or deface that sign will be a criminal offence. In this manner, members of the public will have full knowledge that they may be soliciting a prohibited or illegal business before they enter the property.

Co Clk Sullivan announced that Deputy Clerk Carol Kuhr will be retiring next week after more than 40 years of service with the County. Lori Bensen will be appointed Deputy Clerk.

At 4:21 p.m. it was moved by Anderson and seconded by Rishel to go into closed session for the purpose of discussing attorney client privileged information regarding potential and/or imminent threat of litigation involving Washington County. Vote-Aye:
