The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:00 p.m. on Tuesday, July 9, 2019 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Steve Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Jordan Rishel, Lisa Kramer, Andy Andreasen, Jay Anderson and Steven Kruger. Absent: Bob Frahm. Also present, Co Clk Barbara Sullivan, and Co Atty Scott VanderSchaaf.

Motion Anderson and second by Rishel to approve agenda for July 9, 2019. Vote- Aye: Rishel, Kramer, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Andreasen and seconded by Kramer that the rules be suspended and that the minutes of the June 25, 2019 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Rishel, Kramer, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Claims were received and reviewed, following which it was moved by Kruger and second by Andreasen that the following claims at the end of these minutes be allowed and Clerk ordered to issue warrants on the various funds for the same. Jared Schleifer, Weitz Construction, gave a brief update to Justice Center project.

Bill Hansel, Hwy Supt, gave a brief Road Dept update, not limited to projects, equipment and personnel. Matt Japp spoke and asked about Co Rd 28.

Tim Farmer, Speece Lewis, opened the following 3 bids for Co Rd 32 (aka Kennard Southeast project #C89 202A)): **1.** Luxa Construction, \$4,373,117.84, completion date 10/2020 **2.** Cedar Valley Paving, \$3,997,906.71, completion date 10/2020 **3.** Graham, \$4,327,497.00, completion date 9/2020. Bid bond was included with all bids. Motion Kruger second Kramer to table item until next Board meeting 7/23/19. Vote- Aye: Rishel, Kramer, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Next Hansel stated that after meeting with the Road Committee to discuss the semi-tractor bids opened last meeting, they recommend purchasing the 2020 Mack Granite. Motion Kruger second Andreasen to authorize purchase of a 2020 Mack Granite semi-tractor for \$119,967.10. Vote- Aye: Rishel, Kramer, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Hansel then discussed Change Order from Dixon Construction for C89 (584) bridge on Co Rd 40. Hansel explained that the request for 2 additional drop pipes was a decision from the engineer due to flooding. Motion Kruger second Andreasen to authorize Chairman to sign Change Order. Michael Rooks, Gateway Director, gave an update on Gateway Development Corp. Rooks said that his goal is to be more visible in the County with focus being on the following segments: land development, workforce, and community retail and small business attractions. Rooks also stated that there are currently 8 active leads for new business in Washington Co. Rooks also gave a brief update to activity on the former Dana campus.

Property is located in SE ½ NW¼ NE ¼ and Tax Lots 6 & 7 of Section 8 Township 19 North-Range 10 and N ½ NW ¼ and Tax Lot 4 of Section 9 Township 19 North-Range 10 East of the 6th PM. (General location is CR 15 and CR 10, Herman NE) Planning Commission voted 7-0 on motion to approve the CUP as presented. Chairman opened the public hearing. Sullivan went through request.
