The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:00 p.m. on Tuesday, Aug 27, 2019 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Jordan Rishel, Lisa Kramer, Bob Frahm, Andy Andreasen, Jay Anderson, and Steve Kruger. Also present, Co Clk Barb Sullivan, Sheriff Mike Robinson, Treasurer Marj Hoier, and Co Attorney Scott VanderSchaaf.

Motion Andreasen second Frahm to approve agenda for August 27, 2019. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Anderson and seconded by Rishel that the rules be suspended and that the minutes of the Aug 13, 2019 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Abstain: Andreasen. Motion carried.

Claims were received and reviewed, following which it was moved by Kruger and second by Andreasen that the following claims except for claim to RDO for \$119,967.10 at the end of these minutes be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried. Kruger stated the reason for holding RDO claim is that the loan for the truck has not been received yet.

There was no correspondence.

Matt Cavanaugh, Weitz Construction, gave a brief update to the Washington County Justice Center construction project.

Bill Hansel, Hwy Supt, gave an update to projects. Box on Co Rd 5 is about done after some delays. Western Engineering should return a week after Labor Day to continue work on Co Rd 30 (Rolling Acres). Pre-construction meeting set for second week in Sept for Co Rd 32. Advertising for bids on Co Line Rd are published and bids are set to be opened on Sept 10. Hansel then discussed the Interlocal Agreement between Burt Co and Washington Co for cost share of bridge structure C001105215 and stated Washington County's portion of 50% will be \$68,950. Project will mainly be deck and rail removal and has been on the Road 1 & 6 Year Plan. Motion Kruger second Frahm to authorize Chairman to sign Interlocal Agreement between Burt Co. and Washington Co. Vote-Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Greg Dietrich, Kutak Rock, discussed Resolution 2019-12; Expressing Intent to Issue Tax-Exempt Industrial Development Revenue Bonds. Dietrich stated that Cargill is asking for said resolution to be adopted to issue tax exempt bonds that would go towards replacement and upgrades to waste water and sewage treatment facilities. Bonds would be issued in November and a more detailed and formal resolution would need to be adopted at that time. Motion Kramer second Rishel to waive the reading and adopt Res 2019-12; Expressing Intent to Issue Tax-Exempt Industrial Development Revenue Bonds. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

COUNTY OF WASHINGTON, STATE OF NEBRASKA RESOLUTION NO. 2019-12 RESOLUTION EXPRESSING INTENT TO ISSUE TAX-EXEMPT INDUSTRIAL DEVELOPMENT REVENUE BONDS

WHEREAS, the County of Washington, Nebraska (the "Issuer"), a political subdivision of the State of Nebraska, is authorized and empowered by the provisions of Sections 13-1101 to 13-1110, Reissue Revised Statutes of Nebraska, 1997, as amended (the "Act"), to finance a project, as that term is defined in the Act, and to issue its industrial development revenue bonds (the "Bonds") for the purpose of defraying the cost of acquisition, construction and equipping of a project; and

WHEREAS, Cargill, Incorporated, a Delaware corporation (the "Company"), has requested the Issuer to issue and sell one or more series of its tax-exempt Bonds pursuant to provisions of the Act for the purpose of defraying all or a portion of the cost of

acquisition, construction and equipping of certain wastewater treatment and sewage facilities at the Company's manufacturing facility located in Washington County, Nebraska at 650 Industrial Road, Blair, Nebraska 68008, which wastewater treatment and sewage constitutes a "project", as that term is defined in the Act (the "Project"); and

WHEREAS, the Bonds, if and when issued, will be limited obligations of the Issuer payable solely from payments to be made by the Company under a lease agreement with the Issuer and the Bonds and the interest thereon will not constitute or give rise to a pecuniary liability of or a charge against the general credit or taxing powers of the Issuer and will not be payable from any tax sources; and

WHEREAS, the Issuer wishes to declare its intention to authorize the issuance in one or more series pursuant to a plan of financing of its tax-exempt Bonds for the purpose of defraying all or a portion of the cost of acquisition, construction and equipping of the Project, when so requested by the Company, upon such terms and conditions as may then be agreed upon by the Issuer, the Company and the underwriter or placement agent of the Bonds; and

WHEREAS, the Issuer also desires to declare its official intent to reimburse the Company for capital expenditures of the Project with the proceeds of the Issuer's future borrowing in accordance with Section 1.150-2 of the Treasury Regulations.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the Issuer that it does hereby declare its intention to authorize the issuance and sale of the Bonds in one or more series pursuant to a plan of financing, the interest on which Bonds will be excluded from gross income for federal income tax purposes pursuant to Section 142(a)(5) of the Internal Revenue Code of 1986, as amended, under and in accordance with the Act, in such an amount necessary to defray all or a portion of the cost (including the reimbursement of Project costs previously incurred by the Company in accordance with Section 1.150-2 of the Treasury Regulations) of acquisition, construction and equipping of the Project, presently estimated not to exceed \$32,000,000, and upon such terms and conditions as may be mutually agreed upon by the Issuer, the Company and the underwriter or placement agent, the issuance and sale of each series of such tax-exempt Bonds to be authorized by a resolution of the Issuer at a meeting to be held for such purpose.

AND BE IT FURTHER RESOLVED by the Board of Supervisors of the Issuer, that the Issuer shall cooperate with and assist the Company, its representatives and bond counsel in obtaining an allocation of private activity bond issuing authority for the proposed Bonds from the State of Nebraska.

(General location is CR 13 and CR P10, Herman NE) Planning Commission voted 7-0 on the motion to approve the rezone. Chairman opened public hearing. After no public comments, Chairman closed public hearing. Motion Kruger second Andreasen to concur with Planning Commission and approve rezone request. 3. Cathy Stephens requests text amendment to the zoning regulations and land use matrix in accordance with Section 1.06 and 2.03.226 of the zoning regulations. The request is to add a definition for 'Bed and Breakfast Establishment' to section 2.03.50 and to add 'Bed and Breakfast Establishment' as a conditional use in the Rural Acreage (RA) zoning district. Planning Commission voted 6-1 on the motion to approve the text amendment. Sullivan went through request. Chairman opened public hearing. Applicant Stephens spoke at length with Board and Co Attorney. Mike Anderson and Building Inspector, Kris Robinson also spoke. (General Location is CR 32, Blair NE) Planning Commission voted 7-0 on motion to approve the general development plan. Sullivan went through request. Chairman opened public hearing. Applicant Barry Kolterman and Surveyor Randy Rector spoke. Motion Anderson second Andreasen to concur with Planning Commission and approve general development plan. Vote-Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Marj Hoier, Treasurer, presented Report of the 2017 Personal Property taxes that were turned over to Sheriff's Dept but have not been collected through distress warrant process.
