

**November 12, 2019 Minutes**

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:05 p.m. on Tuesday, November 12, 2019 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Steve Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Jordan Rishel, Lisa Kramer, Bob Frahm, Andy Andreasen, Jay Anderson and Steven Kruger. Also present, Co Clk Barbara Sullivan, Co Sheriff Mike Robinson and Dpty Atty Desirae Solomon.

Anderson requested to have the following item removed from agenda: Sheriff to discuss joining Douglas Co Records Management System. Motion Kramer and second by Andreasen to approve agenda for Nov 12, 2019 as amended. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Andreasen and seconded by Rishel that the rules be suspended and that the minutes of the Oct 22, 2019 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Claims were received and reviewed, following which it was moved by Kruger and second by Anderson that the following claims at the end of these minutes be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Anderson and seconded by Kruger that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$540; Reg of Deeds \$42,938; Co Court \$18,923; Co Plan Dept \$11,765; Clk Dist Crt \$2,159; Sheriff \$11,456; and Road Dept \$; Oct Treas Statement- Collections \$678,198; Disbursements \$2,661,355; Inheritance Tax \$1,217,925; Ending balance \$16,571,484. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

The following correspondence has been received: 1. Notice of public hearing from City of Ft Calhoun Planning Commission regarding Northern Lights subdivision. Motion Kruger and seconded by Andreasen that the correspondence be received and placed on file. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Jared Schleifer, Weitz Construction, gave a brief update on Justice Center project. Scaffolding should be going up soon to start masonry work on exterior. Repairs have been made to damage done by crane on Grant St and pile of steel will start to get moved out.

Bill Hansel, Hwy Supt, gave a brief update to road projects and then discussed bid for 2020 Co Bridge Match Program. Hansel said 2 bridges, both on Co Rd 20, need repair and have bids on them. The program would allow Washington Co to "piggyback" off of Dodge Co and would allow for a larger portion of funds paid back. Motion Kramer second Kruger to approve ME Collins bids in the amount of \$142,857.75 and \$232,254.18 for the total of \$375,111.93. Vote-Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Next Hansel discussed bidding for a single axel dump truck. The 2005 model that is currently being used is needing to be replaced as the underside of truck is rusting out. No state bids are available for a single axel dump truck. Motion Kruger second Anderson to approve the request for bidding for a single axel dump truck. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Hansel then discussed his request to rescind Res 2009-17; Washington Co Driveway Access Rules & Regulations. Hansel said he was not aware of the Resolution and has had residence request secondary driveways mainly due to not wanting to haul heavy equipment across residential driveways. Same rules and regulations would be upheld for secondary driveways and 911 addresses would be designated in the Planning office. Motion Kruger second Andreasen to rescind Res 2009-17; Washington

Co Driveway Access Rules & Regulations. Vote-Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Anderson discussed request for Washington Co to invite NRD to assess Loftis Dam and stated that when attending Village of Herman meeting addressing the issue with the dam it was decided that it would be beneficial to have NRD inspect and assess the dam. The assessment would be at no cost to the county but NRD asked that both the Village of Herman and Washington Co put in a formal request for the inspection. The Village of Herman has already made a motion to invite NRD to assess dam. Ted Japp, NRD, and Ann Loftis, property owner, were both present and spoke. Motion Anderson second Kramer to support letter from Village of Herman in asking NRD to access the dam at no cost to Washington County or obligation to the county on ownership or maintenance. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson. Nay: Kruger. Motion carried.

Mike Robinson, Sheriff, discussed financing for 3 new patrol cars. Robinson stated that 3 Dodge Chargers were to be delivered in Oct, however due to high demand the orders are pushed back until March 2020. Due to the high mileage and maintenance issues with the trade-in vehicles the need to look for other options was imperative. Robinson also said that by the time the Chargers are delivered they will have 3 more patrol cars ready for trade-in. Financing bids were received from the following banks for 3 2019 Dodge Durangos: **1.** Washington Co Bank, 4.20% interest, \$15,106 total per year **2.** Two Rivers Bank, 3.75%, \$15,019 total per year **3.** US Bank, 3.45% interest, \$14,911 per year. Board members discussed issues with required disclosure statements from US Bank. Motion Anderson second Kramer to approve financing for 3 patrol vehicles through Two Rivers Bank. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Rob Bellamy, Jail Administrator, discussed contract signing with Combined Public Communications for Inmate Telephone/Video Visitation Service that was approved in previous Board meeting. Motion Kruger second Andreasen to authorize Chairman to sign contract. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

Ryan Sullivan, Planning & Zoning Administrator, request for Board of Supervisors to appoint members to Planning Commission for a 3 year term. Those who submitted applications were Holly Bonasera, Kevin Hartzell, Steve Neuverth, Terry Rasmussen, Lyle Schjodt, and Cynthia Timmermier. Hartzell and Rasmussen were present and introduced themselves. Co Clerk passed out ballots for Board members to vote for 3. Tallied votes: Bonasera-0, Hartzell-6, Neuverth-5, Rasmussen-2, Schjodt-4, Timmermier-3. Hartzell, Neuverth, and Schjodt were appointed to the Planning Commission to begin term in January.

Marj Hoier, Treasurer, presented letter stating 109 Distress Warrants amounting to \$101,020.44 have been turned over to Co Sheriff for collection.

Kramer discussed meeting with Turnkey Nerds and Anderson, Jail Comm Chairman, where they discussed the VoIP RFP and it was decided to recommend moving forward with Cox Business but to hold off on signing a contract until they can certify compatibility with the County systems and the Co Attorney can approve contract. Motion Kramer second Andreasen to proceed with moving forward with Cox Business pending contract approval from Co Attorney. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Kruger and seconded by Andreasen to designate notice of meetings to be published in the local newspaper: Enterprise and Pilot Tribune, on the County's website [www.co.washington.ne.us](http://www.co.washington.ne.us) and for emergency situations will post a notice at the Courthouse. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Andreasen, Anderson, Kruger. Nay: None. Motion carried.
