December 10, 2019 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair,Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:05 p.m. on Tuesday, December 10, 2019 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman Steve Dethlefs, County Board Members: Jordan Rishel, Lisa Kramer, Bob Frahm, Jay Anderson and Steve Kruger. Also present, Co Clerk Barbara Sullivan, Sheriff Mike Robinson and Co Attorney Scott VanderSchaaf.

Chairman Dethlefs paid tribute to Andy Andreasen in the prior Board of Equalization meeting. Andy passed away suddenly on Dec 5. Andy was a highly valued and respected member of the Board and will be missed dearly.

Motion Kruger second Kramer to approve agenda for Dec 10, 2019. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried. Motion Kruger second Frahm that the rules be suspended and that the minutes of the November 26,2019 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried.

Claims were received and reviewed, following which it was moved by Kurger and seconded by Kramer that the following claims at the end of these minutes be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Anderson and seconded by Kruger that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$273; Reg of Deeds \$28,518; Co Court \$12,975; Co Plan Dept \$9,029; Clk Dist Crt \$4,068; Sheriff \$14,234; and Road Dept \$26,201; Nov Treas Statement- Collections \$9,007,380; Disbursements \$3,387,015; Inheritance Tax \$982,885; Ending balance \$22,191,849. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried. There was no correspondence.

Jared Schleifer, Weitz Construction, gave a brief update to Justice Center project.

Bill Hansel, Hwy Supt, gave an update on Road Dept projects and personnel then discussed Change Order #1 for County Line Rd project. Hansel said the change order is needed due to an over run on dirt but they went under on other items so there is no additional cost to the county. The project will still be \$20,979 below estimate. Board discussed weather if a change order with no additional cost would still need to come before the Co Board. Mike Anderson spoke. Motion Kruger second Rishel to authorize Chairman to sign change order. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried.

Hansel then discussed federal aid money to be paid back for project HRRR 89 (25) that was not completed. In 2012 there was an application for High Risk Rural Road funds for a area around P39 & P36. The project had started but was never completed as design standards had changed and would end up costing the county a considerable amount of money. Amount from state for funds to be paid back is \$23,566. Board and Hansel discussed salt and sand procedures for winter weather. John Orr spoke.

Russ Nelsen, WC Real Estate, discussed request from a title company for an easement on county owned land. Nelsen represents the seller of property to which had access to the land and the title company is requesting the easement. Nelsen said the buyer has expressed interest in buying the county owned land if county is willing to part with it. Co Attorney VanderSchaaf stated his concerns of liabilities and said he has yet to speak with the title company or buyer's attorney. Board discussed at length and decided to address request at next meeting after Co Attorney has a chance to talk to title

company. Motion Kruger second Frahm to table item until more information is available. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried.

At 3:51 p.m. it was moved by Kruger and seconded by Rishel to go into closed session for the purpose of discussing attorney client privileged information regarding current, potential and/or imminent threat of litigation involving Washington County. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried. Those present were 6 Board members and Co Attorney VanderSchaaf. Chairman restated that the closed session was for the purpose of discussing attorney client privileged information regarding current, potential and/or imminent threat of litigation involving Washington County. At 4:13 p.m. it was moved by Rishel and seconded by Kruger to come out of closed session. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried. There was no action in open session.

Board discussed job posting and applicant activity for the Planning & Zoning Administrator position. Dethlefs said that thus far there have been only one applicant and will wait for more to come in before setting up interviews. Board also discussed interim office operations. It was moved by Kruger and seconded by Frahm to authorize Lori Diefenbaugh to sign and conduct Planning & Zoning functions until position is filled. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried. Board discussed at length giving a temporary wage increase for Lori Diefenbaugh and Teresa McBride while position of Administrator is vacant. Co Atty VanderSchaaf, Mike Anderson, and John Orr all spoke. Motion Kruger second Anderson to authorize temporary wage increase for Lori Diefenbaugh and Teresa McBride until position is filled. Kruger amended the motion to include "effective Dec 16, 2019" and Frahm seconded. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None.

Public comments: Mike Anderson spoke.

Committee reports: Finance met with Phil Brazelton regarding E911 budget. Jail met and discussed Justice Center progress. Anderson said that a vendor to which was not ultimately used has given a verbal commitment to refund \$86,000 back to the county. Board discussed the need to reappoint a Chairman for the Building and Grounds Committee to which Bob Frahm was appointed. Board and Co Attorney VanderSchaaf then discussed next steps for appointing a Supervisor for District 7.
