December 23, 2019 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:05 p.m. on Monday, Dec 23, 2019 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Vice Chairman Frahm declared the meeting was in session and that the meeting is being recorded. Vice Chairman made note that the Open Meetings Law is posted on the door and the west wall. Present: Vice Chairman Bob Frahm, County Board Members, Jordan Rishel, Jay Anderson, and Steve Kruger. Absent: Chairman Steve Dethlefs and Lisa Kramer. Also present, Co Clk Barb Sullivan, Sheriff Mike Robinson, and Co Attorney Scott VanderSchaaf.

Motion Anderson second Kruger to approve agenda for Dec 23, 2019. Vote- Aye: Rishel, Frahm, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Rishel and seconded by Kruger that the rules be suspended and that the minutes of the Dec 10, 2019 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Rishel, Frahm, Anderson, Kruger. Nay: None. Motion carried.

Claims were received and reviewed, following which it was moved by Kruger and second by Rishel that the following claims at the end of these minutes be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Rishel, Frahm, Anderson, Kruger. Nay: None. Motion carried. There was no correspondence.

Jared Schleifer, Weitz Construction, was not present to give Justice Center update.

Bill Hansel, Hwy Supt, gave a brief update to Road Dept projects and then discussed request for purchase of 2 new pick-up trucks off of state bid. Hansel said the 2 that need to be replaced are a '99 Ford that need costly repairs and a '02 Chevy that has over 224k miles. State bid prices for a ½ ton crew cab pick-up: \$26,740 Dodge, \$29,862 Ford, \$30,200 Chevy. Motion Anderson second Kruger to approve purchase of 2 Dodge pick-up trucks. Vote- Aye: Rishel, Frahm, Anderson, Kruger. Nay: None. Motion carried.

Next Hansel introduced Chris Lang, Speece Lewis, to discuss change order #1 for Arlington North project. Lang said the change order is needed as the bridge requires additional piling due to not reaching bearing. Change order is for \$41,174.15. Motion Kruger second Rishel to approve change order #1 for \$41,174.15. Vote- Aye: Rishel, Frahm, Anderson, Kruger. Nay: None. Motion carried.

Russ Nelsen, WC Real Estate: request for easement on county owned land, tabled item from 12/10 mtg. Nelsen again stated the reasons for the request. Those who spoke on the matter were City Asst Administrator Phil Green, City Atty Desirae Solomon, Stephanie O'Keefe, and Mike Anderson. Atty VanderSchaaf said that he had yet to hear from the title company that is making the easement request nor the buyer's attorney to which was the reason for tabling the item last Board meeting. Board decided not to take action and leave agenda item tabled until the Co Attorney has spoken to Blair Title and/or buyer's attorney.

Gary Tinkham, Surveyor, discussed election/appointment of county surveyor and stated that if the county board should not adopt a resolution to continue to elect the county surveyor then the question of electing a surveyor in the county shall be submitted to the registered voters of the county at the statewide general election in 2020. Tinkham also stated that the resolution would need to be adopted, following a public hearing, prior to February 1, 2020.

Dan Douglas, Emergency Manager, gave a brief update to the March 2019 flood recovery process and efforts.

Motion Kruger second Anderson to reappoint Chris Bilau, Joe McBride and Gary Lambrecht to the Washington County Board of Adjustments due to members' three year term expiring. Vote- Aye: Rishel, Frahm, Anderson, Kruger. Nay: None. Motion carried. Kruger stated that the 3 reappointed members were the only applicants.

At 4:20 p.m. it was moved by Rishel and seconded by Kruger to go into closed session in order to protect the public interest with respect to discussion regarding personnel. Anderson stated that Chairman Dethlefs, who is absent, called for the closed session and asked that the motion be withdrawn. Rishel withdrew the motion, Anderson seconded. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried.

Board discussed changing Christmas Eve holiday hours to reflect that of state employees for 2020. Chairman read through Res 2019-22; setting the days the Courthouse will be closed in 2020. Motion Anderson second Rishel to adopt Res 2019-22; setting the days Courthouse will be closed in 2020.
