The Washington County Board of Equalization of Washington County, Nebraska, met in regular session at 300 p.m. on Tuesday, Feb 25, 2020 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk.
