The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:15 p.m. on Tuesday, April 14, 2020 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Steve Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Jordan Rishel, Lisa Kramer, Bob Frahm, Kevin Barnhill, Jay Anderson and Steven Kruger. Also present, Co Clk Barbara Sullivan, and Co Atty Scott Vander Schaaf.

Motion Anderson and second by Kruger to approve agenda for May 14, 2020. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Rishel and seconded by Kramer that the rules be suspended and that the minutes of the Mar 20, Mar 24, and April 2 meetings be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

Claims were received and reviewed, following which it was moved by Kruger and second by Barnhill that the following claims at the end of these minutes be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Rishel and seconded by Kramer that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$489; Reg of Deeds \$37,701; Co Court \$15,419; Co Plan Dept \$12,468; Clk Dist Crt \$2,737; Sheriff \$1,764; and Road Dept \$221,988; Mar Treas Statement- Collections \$1,550,570; Disbursements \$3,892,429; Inheritance Tax \$1,284,240; Ending balance \$16,385,162. Bill Hansel, Road Supt, gave a review of the bids that were received and opened at the last board meeting on Mar 24 and gave his recommendation to award bid to Western Asphalt. Motion Kruger second Frahm to award asphalt bid to Western Asphalt for \$693,689. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

Hansel then gave a brief update to Road Dept projects and personnel.

Kris Robinson, Building Inspector, discussed Res 2020-06; 2018 Resolutions and Appendices and gave a review of some of the items that were affected and reasons for the needed update. WHEREAS, the Nebraska Legislature has adopted LB348 the 2018 IBC, 2018 IRC, 2018 EBC effective July 19, 2019 with changes as per State of Nebraska for the 2018 IBC and 2018 IRC and LB130 Nebraska Radon Resistant New Construction and the 2018 IECC adopted as of July 1, 2020:

Kramer discussed the Tech Committee's recommendation for firewall and went through quote from Turnkey Nerds that included options for a 1, 3, or 5 yr protection plan. Next Kramer discussed internet fiber bids for internet connection for the Courthouse and Sheriff's office. Kramer stated that courthouse is currently using American Broadband for internet but would like to get improved speeds. Kramer also said that the intention was to have 2 separate internet fiber links with diverse geographical fiber connections. Board discussed whether to get two fiber links or to go with only one and possibly get a secondary fiber if needed later. A representative from Cox Communications and James Urwiller, Turnkey Nerds, spoke on the matter. Motion Dethlefs second Kruger to accept internet fiber connection from American Broadband for \$50/month for 24 months. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.
