May 11, 2020 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:12 p.m. on Monday, May 11, 2020 and was conducted via video teleconference. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Steve Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Jordan Rishel, Lisa Kramer, Bob Frahm, Jay Anderson and Steven Kruger. Absent: Kevin Barnhill. Also present, Co Clk Barbara Sullivan, and Co Atty Scott Vander Schaaf.

Motion Kruger and second by Kramer to approve agenda for May 11, 2020. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Anderson and seconded by Frahm that the rules be suspended and that the minutes of the April 28 & May 4 meetings be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried.

Claims were received and reviewed, following which it was moved by Kruger and second by Rishel that the following claims at the end of these minutes be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote-Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Kramer and seconded by Frahm that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$299; Reg of Deeds \$40,593; Co Court \$6,298; Co Plan Dept \$12,506; Clk Dist Crt \$2,177; Sheriff \$1,375; and Road Dept \$1,399; April Treas Statement- Collections \$4,044,230; Disbursements \$3,472,353; Inheritance Tax \$1,324,949; Ending balance \$17,957,039. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None.

It was moved by Kruger and seconded by Kramer to receive and place on file correspondence from: 1. Region 6 county match requirement for Washington Co, \$60,309 for FY 2021. 2. Letter from NACO regarding Health Insurance pool. 3. Letter from City of Ft Calhoun Annual TIF Report. Vote-Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried.

Jared Schleifer, Weitz Construction, gave a brief update to Justice Center project.

Bill Hansel, Road Supt, gave a brief update to Road Dept projects and personnel then discussed Change Order from Speece Lewis for project C89 (202) for the increased amount of \$1,273.47. Motion Anderson Second Kramer to authorize Chairman to sign Change Order for project C89 (202). Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried.

Next, Hansel discussed Change Order from Speece Lewis for Wiebers & Ohrt Dam Repair for the increased amount of \$7,595.18. Motion Kruger second Frahm to authorize Chairman to sign Change Order for Wiebers & Ohrt Dam Repair. Vote-Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried.

Hansel then discussed Fracture Critical and routine bridge inspections. This was discussed at the last board meeting and Hansel stated that he met with the Road Comm since then at it was recommended to hire out for the one bridge due this year and then look at it again for the 8 bridges due next year. Motion Anderson second Kruger to hire a consultant, Speece Lewis, for Fracture Critical Bridge Inspection for \$1,450. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried. Hansel went on to say that he currently does the routine bridge inspections but would like to have someone else go through the required training so they are qualified before he is set to retire.

Kramer discussed the Tech Committee's recommendation for secondary internet fiber option and said after reviewing the RFPs received they are recommending American Broadband for both primary and secondary internet connections. Motion Kramer

second Rishel to authorize Chairman to sign fiber agreements with American Broadband. Vote-Aye: Kramer, Rishel, Frahm, Dethlefs, Anderson, Kruger. Nay: None. Motion carried.

Kramer then discussed Customer Proprietary Network Information (CPNI) authorization for American Broadband and said the reason is to give the county's IT personnel permission to engage in conversations about the internet and telephone features with ABB. Board and Co Atty VanderSchaaf discussed some of the details of the agreement. Motion Kramer second Anderson to authorize Chairman to sign CPNI authorizing James Urwiller to access phone and internet information. Vote- Aye: Rishel, Kramer, Frahm, Dethlefs, Anderson. Nay: Kruger. Motion carried.

Comments from public: Cub Scouts Jacob and Isaac spoke. Board members gave a brief update to Committee meetings.
