The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:09 p.m. on Tuesday, June 23, 2020 in the Supervisor's meeting room and was conducted via video teleconference. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Steve Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall. Present: Chairman, Steve Dethlefs, County Board Members, Jordan Rishel, Bob Frahm, Kevin Barnhill, Jay Anderson and Steven Kruger. Absent: Lisa Kramer. Also present, Co Clk Barbara Sullivan and Co Atty Scott Vander Schaaf.

Motion Anderson and second by Kruger to approve agenda for June 23, 2020. Vote- Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

It was moved by Rishel and seconded by Kruger that the rules be suspended and that the minutes of the June 9, 2020 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

Claims were received and reviewed, following which it was moved by Kruger and second by Anderson that the following claims at the end of these minutes be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

Motion Kruger second Frahm to receive and place on file correspondence from the following: 1. Card from NIRMA Board of Directors. 2. Notice of Public Hearing from City of Blair Planning Commission. 3. Anonymous letter from a concerned business owner. Vote- Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

Jared Schleifer, Weitz Construction, gave a brief update to Justice Center project.

Bill Hansel, Hwy Supt, gave an update to Road Dept projects and then discussed contract for maintenance of township roads. Hansel said the contract did not change from last years and is set at \$1,475 per mile. Motion Kruger second Rishel to authorize Chairman to sign township agreements. Vote- Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

Next Hansel discussed two change orders for project C89. Motion Kruger second Rishel to approve change order for C89 (202) for the decreased amount of \$5,040.50. Vote- Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried. Motion Kruger second Rishel to approve change order for C89 (555) for the decreased amount of \$7,475.09. Vote-Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

Hansel then discussed request to purchase 2 motor graders that are due to be replaced in Oct & Nov and said they are the last two that have a buy back. Motion Anderson second Kruger to authorize Hansel to obtain price quotes. Vote- Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

Sheila & Paul Czapla discussed safety concerns as it relates to road work on Co Rd 32 with board members and Hwy Supt. Several other citizens voiced their concerns and/or support of the construction efforts.

Michael Rooks, Gateway Director, discussed request for funds from Washington County for a housing study and stated that several other local political subdivisions have already committed to funding. Rooks said a NIFA grant will pay up to 49% for the study so they are looking to have \$15,300 come from contributions from local political subdivisions. Thus far they have \$10,500 committed to the study. Motion Kruger second Rishel to approve contributing \$2,400 towards the housing study. Vote—Aye: Rishel, Frahm, Dethlefs, Barnhill, Kruger. Nay: Anderson. Motion carried.

Chris Shewchuk, Planning, discussed appointing Jeff Shaner to the Board of Adjustments to fill an unexpired term ending February 2022. Motion Kruger second Rishel to appoint Jeff Shaner to the Board of Adjustments. Vote- Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

Public hearing: Lee McCoy requests approval of a CUP on the west ½ of the northeast quarter of the northwest quarter, Sect 5-17-12, to allow a temporary second dwelling during construction of a new dwelling on property zoned A-1. Location is 9505 Lost Valley Ln, Blair. Shewchuk went through request. Chairman opened public hearing. There were no public comments. Motion Anderson second Frahm to approve CUP request as presented. Vote- Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

Public hearing: Melissa Lester requests approval of a CUP on Tax Lot 67, Sect 35-17-12 to operate a dog obedience training facility in a residential outbuilding on property zoned A-1. Location is 7902 Dutch Hall Rd, Omaha. Shewchuk went through request. Chairman opened public hearing. Applicant Lester and her attorney Brad Entwistle spoke. Several citizens spoke in favor and against the CUP request. Chairman closed the public hearing. Board discussed the CUP request at length. Motion Kruger second Rishel to approve CUP request. Vote- Aye: Rishel, Frahm, Dethlefs, Kruger. Nay: Barnhill, Anderson. Motion carried.

Scott Vander Schaaf, County Attorney, discussed the Burt Co interlocal agreement in regards to Drug Court and answered questions from board members. Ed Talbot, Burt Co Attorney spoke. Motion Kruger second Anderson to approve interlocal agreement with Burt Co. Vote- Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

Vander Schaaf then discussed the microwave tower located in Burt Co that was purchased with grant funds prior to the disbandment of Region 5/6 Emergency Management. Vander Schaaf stated that a Reformation of the Quit Claim Deed would be the preferred method of transferring title to the tower to Burt Co. Attorney Ed Talbot spoke. No board action was taken.

Jay Anderson stated that the Jail Committee did not meet to discuss the replacement of plumbing fixtures in the existing jail cells. Motion Kruger second Rishel to table until new information comes forward from Weitz Construction. Vote- Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

Chairman read through Resolution 2020-12; End of Budget Year transfer of money to Sheriff's Office, Communications Center and Building Inspector budgets. Motion Rishel second Kruger to adopt Res 2020-12. Vote- Aye: Rishel, Frahm, Dethlefs, Barnhill, Anderson, Kruger. Nay: None. Motion carried.

RESOLUTION #2020 - 12

BE IT FURTHER RESOLVED, that an additional five hundred dollars (\$500.00) of budget authority is hereby allocated to the Building Inspector function 609 from the Planning and Zoning budget 608.
