The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:06 PM on August 11, 2020 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. BE IT RESOLVED BY THE COUNTY BOARD OF SUPERVISORS OF WASHINGTON COUNTY, NEBRASKA:

Section 1. Pursuant to this Resolution and pursuant to Section 23-107 Reissue Revised Statues of Nebraska, there is proposed the sale and conveyance of a tract of land consisting of a portion of the southwest right–of-way adjacent to County

Road P32, resulting from the relocation and improvement of said County Road P32, which includes the following property, none of which is located within a village or city:

A TRACT OF LAND LOCATED IN A PORTION OF A PARCEL OF LAND DESCRIBED IN BOOK 332, PAGE 428 LOCATED IN THE WEST HALF OF THE NORTHWEST QUARTER OF SECTION 8, TOWNSHIP 17 NORTH, RANGE 12 EAST OF THE SIXTH P.M., WASHINGTON COUNTY, NEBRASKA, BEING DESCRIBED AS FOLLOWS: REFERRING TO THE NORTHWEST CORNER OF SAID SECTION 8; THENCE S00°31'42"W (ASSUMED BEARING) ON THE WEST LINE OF THE NORTHWEST QUARTER OF SAID SECTION 8, A DISTANCE OF 963.17 FEET TO THE WESTERLY RIGHT OF WAY LINE OF COUNTY ROAD P32 AS DESCRIBED IN DEED BOOK 332, PAGE 428; THENCE S20°48'04"E ON SAID WESTERLY RIGHT OF WAY LINE, A DISTANCE OF 36.04 FEET; THENCE S40°29'10"E CONTINUING ON SAID WESTERLY RIGHT OF WAY LINE, A DISTANCE OF 25.20 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING S40°29'10"E ON SAID WESTERLY RIGHT OF WAY LINE, A DISTANCE OF 99.09 FEET; THENCE S53°24'33"E CONTINUING ON SAID WESTERLY RIGHT OF WAY LINE, A DISTANCE OF 408.39 FEET; THENCE NORTHWESTERLY ON A 851.28 FOOT RADIUS NON-TANGENT CURVE TO THE RIGHT, AN ARC DISTANCE OF 366.19 FEET, TO THE CHORD OF SAID CURVE BEARS N33°44'07"W, A DISTANCE OF 363.37 FEET; THENCE N21°26'30"W, A DISTANCE OF 127.00 FEET; THENCE S68°51'27"W, A DISTANCE OF 76.98 FEET; THENCE S59°20'43'W, A DISTANCE OF 59.77 FEET; THENCE S25°37'12"W, A DISTANCE OF 48.08 FEET TO THE POINT OF BEGINNING, CONTAINING 0.92 ACRES. MORE OR LESS.

Section 2. Said tract is found and determined to constitute a tract which is of no useful purpose or value to the County or of benefit to the configuration and maintenance of said County Road P32 by the County, and by the conveyance of said tract, the County is able to eliminate the County's maintenance, which maintenance becomes the obligation of the transferee upon such conveyance, freeing the County of related costs and expense and returns the said tract to the County's tax rolls.

Section 3. In compliance with Section 23-107.01 Reissue Revised Statues of Nebraska, the Board of Supervisors shall hold a public hearing on the issue of the sale and conveyance of said described tract after notice of such required public hearing by publication for two consecutive weeks immediately prior to such hearing date.

Section 4. Following the public hearing, the County shall schedule a sale date when the tract shall be offered to the highest bidder, which sale date shall be advertised by publication of a notice of such sale date not less than ten days prior to said proposed sale date.

Section 5. This Resolution shall take effect and be in force after its passage and approval as provided by law.

12.1. Discuss financing alternatives for the completion of CR 32- D/PA

Andy Forney, DA Davidson, discussed options for financing Rural Road Improvement 2016-02. and presented a 7 year and 10 year bond plan. Total interest on a 7 yr bond would be \$85,322 and \$138,877 on a 10 yr bond. Kramer read minutes from April 2019 meeting where the board unanimously voted to finance the project out of the General Fund. Board discussed options at length.
