quote from Tiger Corp off of state bid for a boom mower in the amount of \$192,272. Road dept has currently been using backhoes and having to close roads in order to clear areas. Money in the Inheritance Tax Fund was used to pay for expenditures out of Hard Surfacing Fund, so there are no changes to the proposed tax request amount or tax levy.
