## **RESOLUTION NO. 2021-38**

A RESOLUTION PROVIDING FOR AMENDING THE WASHINGTON COUNTY ZONING REGULATIONS.

WHEREAS, the Board of Supervisors of Washington County, Nebraska, deem it to be in the interest of the public health, safety, morals, comfort, and general welfare of said county and its residents that an amendment be made to the WASHINGTON COUNTY, NEBRASKA, ZONING REGULATIONS; and

WHEREAS, the Planning Commission of Washington County, Nebraska, has, after a public hearing, recommended amending the ZONING REGULATIONS.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF WASHINGTON COUNTY, NEBRASKA, that Section 2.03.164 of the Washington County Zoning Regulations be amended to read as follows:

2.03.164 <u>LOT</u> shall mean a parcel or tract of land which is or may be occupied by a use herein permitted, together with yards, and other open spaces herein required, that has frontage upon a street, and is a part of a recorded subdivision plat or has been recorded prior to the adoption of the Regulation; or a parcel of real property delineated on an approved record of survey, lot-split or sub-parceling map as filed in the office of the Register of Deeds and abutting at least one public street or right-of-way. Regardless of the zoning district, all lots shall have a minimum of twenty feet of frontage on a public street, right-of-way, or other County approved roadway.

BE IT FURTHER RESOLVED by the Board of Supervisors of Washington County, Nebraska, that the amendment set forth herein is hereby adopted and shall be in full force and affect from and after its adoption, publication, and filing as provided by law and all resolutions or parts of resolutions in conflict herewith are hereby repealed.
