The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 4:07 PM on June 14, 2022 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. - 7. Bill Hansel, Hwy Sup, gave a brief update on Road Dept projects and equipment.
- 7.1. Adopt Res 2022-12; for Co Rd 29 between 22 & 24 for Road Improvement. D/PA

Hansel said that the minimum design standards for this classification of roadway require newly constructed paved roads to meet a design speed of 55 mph and that meeting the statutory design speed would increase environmental impacts that would require mitigation, which would substantially increase project costs. Relaxation of the design standard would reduce or eliminate environmental mitigation costs. Board members discussed budget concerns.

RESOLUTION 2022-13

WHEREAS, Washington County, Nebraska desires to replace County Bridge No. C89(31920) and re-align New York Creek Road, from County Road P10 to the south approximately 490 feet; and

WHEREAS, said construction is included in Washington County's 1- and 6-year plan; and

WHEREAS, this road is designated a Local Road in the National Functional Classification and in the State Functional Classification; and

WHEREAS, the minimum design standards according to the Rules and Regulations of the Board of Public Roads Classifications and Standards, Title 428 of the Nebraska Administrative Code, for this classification of roadway requires newly constructed paved roads to meet a design speed of 50-mph; and

WHEREAS, New York Creek Road provides public access to two (2) parcels of land less than 500 feet south of County Road P10; and

WHEREAS, designing the project to meet the statutory design speed would increase environmental impacts to a level that would require mitigation that increases the cost of the project; and

WHEREAS, Washington County, Nebraska is seeking a relaxation of the design standards to the roadway alignment to reduce or eliminate the environmental mitigation costs;

NOW, THEREFORE, BE IT RESOLVED BY THE CHAIRMAN OF THE BOARD AND THE BOARD OF COUNTY SUPERVISORS OF WASHINGTON COUNTY, NEBRASKA, that the request to seek a relaxation of standards is hereby approved.

BE IT FURTHER RESOLVED, that the County Highway Superintendent is hereby authorized and directed to execute such request on the behalf of Washington County, Nebraska.

Dollar General Dist Center is currently staffing local management and Scooters in Blair and Family Dollar in Ft Calhoun have recently opened. Holiday Inn Express should open next month and Novazimes is also building a new site. Rooks stated that Gateway is also focused on affordable housing developments.
- 12. Rod Storm, City of Blair Administrator: Discuss Blair Airport expansion/ road relocation project. D/PA Storm discussed proposed options for the relocation of County Roads 35 & 38 to be compliant with the FAA for the Blair Airport runway expansion. Planning Admin, Chris Shewchuk discussed platted lots that would be impacted. Gary Johnson and Carrie Nelson, property owners near proposed relocated roads, spoke in opposition to relocating the roads. Neighboring property owner Gary Johnson also spoke and gave his suggestions on the placement of roads. Darren Peckne, SID #5 Chairman, asked that any board action be delayed until after next SID meeting set in July. Kathy Lyons also asked to have any action be postponed until after SID meeting. Mike Anderson, Todd Cornwell, and Drew and Maria Bledsoe of Skinny Bones also spoke. Dan Hunt, Blair Airport Authority, stated that Blair is one of the fastest growing airports in Nebraska and reiterated the need for expansion.
