The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:07 PM on March 28, 2023 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. The road crew continue to haul rock and as soon as the spring rains subside, they will start laying gravel. Crowning projects will also be starting soon. Crack sealing work is about 3/4 complete on all the paved roads and patch work has started on Co Rd 32 in Ft Calhoun.

7. Julie Ashton, Washington County Historical Museum: Discuss placing historical marker on the courthouse grounds.

Ashton displayed examples of the two different signs that the Historical Museum is erecting in different areas of the county. Ashton stated they would like to have a sign installed for the courthouse and would like the board to give permission and suggestions on where to be placed. There is no cost to the county as the project is funded by a grant and the City of Blair. Board members stated they would like the Building and Grounds Committee to recommendation on location.
