The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:03 PM on April 25, 2023 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgement of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice of the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Steve Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall.

1. Meeting called to order

Present: Chairman Steve Dethlefs, board members Jon Stewart, Lisa Kramer, Kevin Barnhill, Jay Anderson, and Steven Kruger. Absent: Bob Frahm. Also present: Co Clerk Barbara Sullivan, Chief Deputy Kevin Willis, and Co Attorney Scott Vander Schaaf

2. Approve agenda

3. Approve minutes for the April 11, 2023 meeting

Property is legally described as Tax Lot 10 in Section 17, Township 18 North, Range 11 East of the 6th P.M. Location is 15251 County Road 22, Blair. D/PA

Shewchuk stated the Planning Commission voted 7-0 in favor of recommending approval of the CUP for a 2 yr term. Chairman Dethlefs opened a public hearing. Applicant Tim Burkhardt spoke, there were no other public comments. Motion Steve Kruger and second by Jay Anderson to approve the request of Tim and Tinna Burkhart for a Conditional Use Permit to temporarily allow two single-family dwellings on Tax Lot 10 in Section 17-18-11, for a two-year term. Motion Steve Kruger and second by Jay Anderson to approve the request of Robert Dailey, for Consolidated Concrete, LLC, to operate a temporary concrete batch plant on Tax Lot 18 in Section 1-17-12, for a two-year term. Motion Carried.

Motion Jay Anderson and second by Kevin Barnhill to approve the request of Derrick Schneider for a Conditional Use Permit to temporarily allow two single-family dwellings on Tax Lot 13 in Section 20-18-11 for a two-year term. Shewchuk went thru the request and the applicant, Stork spoke. Supervisor Kramer had concerns about site distance for future driveway access. The board suggest that the applicant work with the Road Dept to discuss driveway access and will table both requests until then.

Shewchuk discussed the request and said the Planning Commission voted 7-0 in favor of recommending approval. Applicant Aaron Doll answered questions from board members and addressed concerns about visibility on the highway. There were no comments during the public hearing.

Motion Steve Kruger and second by Kevin Barnhill to approve the request of Aaron and Michael Doll for a Conditional Use Permit to operate a borrow pit on the NW1/4 of the SE14, Tax Lot 12, the N1/2 of the SW1/4, and Tax Lot 13 in Section 10-18-9, for a two-year term. Motion Carried.
