The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:00 PM on November 28, 2023 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given to the members and a copy of their acknowledgement of the receipt of notice and the agenda are on record at the office of the County Clerk.
