The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:00 PM on February 27, 2024 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. notice of the meeting was given to the members and a copy of their acknowledgement of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice of the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Steve Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall.

## 1. Meeting called to order

- 6. Dave Kruger, Hwy Supt: Road Dept update not limited to projects, equipment, and personnel Forman Bob Smith gave an update and displayed photos of various road projects.
- 7. Chris Shewchuk, Planning and Zoning Administrator--Public hearing on the request of Donald and Alice Johnson for approval of the final plat of Blessed Acres, a three-lot residential subdivision. The property is legally described as Tax Lot 52 in Section 3-17-12 and Tax Lot 79 in Section10-17-12. The general location is 6097 North Ridge Road, Fort Calhoun. D/PA

Shewchuk said it is the final plat of the 3-lot subdivision requested by the Johnsons and that the preliminary plat was approved in December. The Planning Commission voted 5-0, with 2 absent, to recommend approval. Chairman Dethlefs then opened a public hearing to which there were no comments.

8. JoEllen Maras, Washington County Food Pantry: Request funding from ARPA or LATCF. D/PA

Kelli Shaner and Cece Tonn discussed their request for ARPA funds for the Washington County Food Pantry. They stated the funds would be used to upgrade the pantry's van as they need a larger cargo van with a high roof for additional shelving space. Shaner said the estimated cost for a new cargo van with wrap and interior shelving work would be about \$81,000. Kramer asked if the current minious would be sold and asked to have them get a quote after trade. Barnhill

asked if they applied for any grants. Dethlefs suggested that the Finance Committee discuss and make a recommendation at next board meeting. Mike Anderson spoke.

- 9. Ed Lautrup, Veterans Service Officer: Discuss replacement of Veteran grave makers at Ft Calhoun Cemetery. D/PA Lautrup showed board members an example of what the markers look like and said over 80 markers at the Ft Calhoun cemetery went missing sometime after Memorial Day 2023. Lautrup said that the county is responsible for furnishing such markers, but the cost to replace them will exceed the current budget for such expenses. Kruger said adjustments to the General Fund budget can be made at the end of the fiscal year. Kramer motioned to approve up to \$3,500 for grave markers. Barnhill asked if there should even be a motion as there would just need to have a claim submitted. Attorney Brantley agreed that a motion is not necessary. Kramer rescinded the motion.
- 10. Approval of Final Agreement with MAPA to obtain digital map products for the region. D/PA Dethlefs stated that the contract was already approved and that the current agreement is just to approve the payment schedule. Kruger said he will not be voting in favor as he believes the service is unnecessary.
